Subject:- Enrolment of those retired AIS pensioners/family pensioners under WBHS, 2008 who have rendered services in the affairs of the **State** and **not** enrolled under the Central Government Health Scheme (CGHS).

The Government of West Bengal, Finance Department, Audit Branch, Medical Cell, in their Notification No 9021 − F (MED) dated 16/09/2011 has decided to extend the benefit of West Bengal Health Scheme, 2008 to the retired members of All India Services who rendered services in the affairs of the State and <u>not</u> enrolled under the Central Government Health Scheme (CGHS) on payment of <u>one-time</u> contribution of ₹40,000/- (Rupees Forty Thousand) only.

The respective Pension Sanctioning Authority will enroll the names of such pensioners/family pensioners following the provisions of the West Bengal Health Scheme, 2008. The said Authority will also settle the claim for re-imbursement of such retired AIS pensioners/family pensioners. Except one-time contribution, all other terms and conditions of the Scheme will remain same for such AIS pensioners/family pensioners.

All concerned Pension Disbursing Authorities are requested to display a copy of this circular in the Notice Boards and to intimate the fact to such All India Services pensioners/family pensioners so that the willing pensioners/family pensioners of this category can enroll their names under West Bengal Health Scheme, 2008.
