Sub:-Payment of relief on total of all pensions when a pensioner/family pensioner is in receipt of more than one pension

In continuation to this office circular No. Pen.Co-ordn/258/Vol-II/228 dated 3/2/2012, it is stated that Govt. of West Bengal, Higher Education Department, University Branch in their Memo No.557-Edn(U) dated 1/6/2012 have since decided that in case of the pensioners/family pensioners of State Aided Universities who are in receipt of more than one pension, the relief on their pension, where admissible, will, with effect from 1/6/2012, be payable on the total of all pensions taken together in analogy of Memo No. 7533-F dated 6/7/88 of Govt. of West Bengal, Finance

The pensioners/family pensioners of the Ex-Management employees of North Bengal Medical College whose pension is regulated under University Pension Rule will come under the purview of the above Memo dated 1/6/2012.

All Pension Disbursing Officers are, therefore, requested to regulate such cases accordingly.
