

No.2/51/2008-1Pension.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (Revised Pension) Part-II, Rules, 2009, namely:-

- 1. (1) These rules may be called the Haryana Civil Services (Revised Pension) Part- II (Amendment) Rules, 2013.
 - (2) They shall be deemed to have come into force on Ist day of January, 2006.
- 2. In the Haryana Civil Services (Revised Pension) Part-II Rules, 2009 in Rule-15 after clause (C), the following explanation shall be added at the end, namely:-

हरियाणा सरकार वित विमाग अधिसूचना

दिनांक 4 अक्तूबर, 2013

भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन) भाग II नियम, 2009 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात:—

- 1. (1) ये नियम हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन) भाग II संशोधन नियम, 2013, कहे जा सकते हैं।
 - (2) ये नियम जनवरी, 2006 के प्रथम दिन से लागू हुये समझे जायेंगें।
- 2. हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन) भाग II नियम, 2009 में नियम 15 में खण्ड (ग) के बाद अन्त में, निम्नलिखित व्याख्या जोड़ दी जाएगी, अर्थात:—

"व्याख्या:— यदि कोई व्यक्ति मूल संराशिकरण की राशि के जारी करने के बाद, किसी भी कारण से, अतिरिक्त संराशिकरण की राशि का हकदार बनता है, तो ऐसी अतिरिक्त संराशिकरण के मद्धे वसूली ऐसी तिथि से प्रभावी होगी जिससे मूल वसूली प्रारम्भ की गई थी।"
