

In continuation of the Government orders under reference the Government has extended the following benefits vide Government Order No. FD(Spl) 2018 PEN 2012 dated 5.06.2013 to Government employees on 1996 UGC/AICTE/ICAR scales of pay who have retired/died on or after 1.1.2006 but before 1.4.2012 and without getting the benefit of 2006 UGC/AICTE/ICAR scales of pay:

(i). Revised (consolidated) pension/family pension contemplated in Go No. FD (Spl) on PEN (II) dated 6.6.2007 excluding Para 2.1(iv) thereof & subject to the conditions/limitations stipulated therein Further the Dearness Allowance has to be allowed on such revised (consolidated) pension/family pension at the following rates.

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub:- Revision of Pension / Family Pension in respect of Teachers on 1996 UGC/AICTE/ICAR scales of pay who retired/ died on or after 1-1-2006 and before 1-4-2012 prior to getting the benefit of 2006 UGC/AICTE/ICAR pay revision – regarding.

Read: 1. G.O. No. FD (Spl) 03 PEN 2007 (II) dated 6-6-2007. 2. G.O. No. FD (Spl) 81 PEN 2012 dated 03-05-2012.

PREAMBLE:

The Government had extended the benefit of 2006 UGC/AICTE/ICAR Scales of pay to various categories of Teachers who were covered by the 1996 UGC/AICTE/ICAR scales of pay from 1-1-2006 and in some cases from dates subsequent to 1-1-2006 but before 1-4-2012.

As per the policy of the Government, the Pension of the Teachers on UGC/AICTE/ICAR scales of pay is regulated by the State Government orders.

The question of revision of Pension/ Family Pension in respect of Teachers on 1996 UGC/AICTE/ICAR Scales of pay who have retired/died on or after 1-1-2006 but before 1-4-2012 prior to getting the benefit of 2006 UGC/AICTE/ICAR scales of pay has been considered by the Government and the following orders are issued.

GOVERNMENT ORDER NO. FD (Spl) 218 PEN 2012 BANGALORE, DATED 5th JUNE 2013.

Government are pleased to extend the following benefits to the Teachers on 1996 UGC/AICTE/ICAR Scales of Pay who have retired/died on or after 1-1-2006 and before 1-4-2012 prior to getting the benefit of 2006 UGC/AICTE/ICAR Scales of Pay:
