Pension- Sanction of further instalments of Dearness Allowance to the Ex-gratia beneficiaries – Orders - Issued.

Read the following:-

3. From the Government of India, Ministry of Personnel, Public Grievances and Pensions Department of Pension and Pensioners' Welfare Office Memorandum F.No.42/13/2012-P&PW(G), dated: 24.5.2013.

ORDER:

In the Government Order first read above, orders have been issued sanctioning Dearness Allowance at the rate of 27% to the regular pensioner/family pensioner with effect from 1.7.2009 consequent on the revision of pension effected from 1.1.2006. In the above order, it has been ordered that in respect of the widows and children of the deceased Contributory Provident Fund/ Non pensionable establishment beneficiaries of State Government and the former district board who are drawing Ex-gratia pension, necessary orders shall be issued separately.

2. In the Government Order second read above, the last sanction of Dearness Allowance for the Ex-gratia pensioners has been ordered at 56%. As further revision in the quantum of pension to the Ex-gratia pensioners were not granted by the Government of India, requests have now been received from various Associations for sanction of admissible Dearness Allowance as allowed to the regular pensioners/ family pensioners. The Government after careful consideration and taking into account the Memoranda, issued by the Government of India, decided to accept the same and accordingly sanction

the enhanced rate of Dearness Allowance to the Ex-gratia pensioners with effect from 1.7.2009 to 1.1.2013 at the rates mentioned below:-

3. The expenditure on Dearness Allowance to those who are in receipt of Ex-gratia payment of Rs.605/- per month shall be debited to

"2071 Pension and Other Retirement Benefits - 01 Civil - 800 Other Expenditure - I. Non-Plan - AH Ex-gratia payment to families of deceased — Non-Provincialised Employees - Contributory Provident Fund - 27 Pensions - 09 Others.

(DP Code 2071 01 800 AH 2795)"

- 4. The above Ex-gratia pensioners are entitled for the arrears of Dearness Allowance at the rates ordered in para -2 above with effect from 1.7.2009.
- 5. Pending formal authorisation by the Accountant General, the revised Dearness Allowance shall be paid straightaway by the Pension Pay Officer, Chennai-6, Treasury Officers and Public Sector Banks concerned.

PENSION – Tamil Nadu Government Pensioners' Family Security Fund Scheme– Enhancement of financial assistance from Rs.35,000/- to Rs.50,000/- in the case of death of pensioner – Orders – Issued.

ORDER:

In the Budget Speech for 2013-2014, an announcement has been made by Government to enhance the financial assistance under the Tamil Nadu Government Pensioners' Family Security Fund Scheme from the present level of Rs.35,000/- ordered in the Government Order fourth read above to Rs.50,000/- in the event of death of the pensioner.

2. Accordingly, the Government direct that the financial assistance under the Tamil Nadu Government Pensioners' Family Security Fund Scheme shall be enhanced from Rs.35,000/- to Rs.50,000/-(Rupees fifty thousands only) in the event of death of the pensioners.

- 3. The Government have also decided to enhance the pensioners' contribution and accordingly direct that the contribution towards Tamil Nadu Government Pensioners' Family Security Fund Scheme be increased from Rs.70/- per month to Rs.80/- (Rupees eighty only) per month.
- 4. There shall be no change in the existing rules and regulations governing the sanction of assistance under the Tamil Nadu Government Pensioners' Family Security Fund Scheme.
 - 5. This order takes effect from the date of issue of this order.
