Subject: Revision of rate of Medical Allowance to State Government Employees and Pensioners etc.

The Assam Pay Commission, 2008 recommended for introduction of a Comprehensive Health Insurance Scheme covering both indoor and outdoor treatment in respect of State Govt. employees and pensioners and also recommended continuance of the existing rate of Medical Allowance as an interim measure. Govt. of Assam has also resolved that existing provision regarding medical facilities and benefits shall continue till the time of further examination and decision on the recommendations of the Commission. The Comprehensive Health Insurance Scheme is yet to be implemented as some examination and discussions on it are yet to place. In view of above stated reason and also in consideration of the hardship caused to the Govt. employees due to rise in cost of medical treatment, the Governor of Assam is pleased to increase the existing rate of Medical Allowance to all categories of State Govt. employees, pensioners including family pensioners to Rs.600/- (Rupees Six hundred) only per month from the existing rate of Rs.350/-per month as revised by Health & Family Welfare Deptt. vide their letter No.HLA.198/2004/11 dtd.8-6-2004.

This will be effective from 1-4-2012 and will continue till introduction of the Comprehensive Health Insurance Scheme in line of Govi, of India CGHS. As soon as the Comprehensive Health Insurance Scheme is launched the present practice of payment of Medical Allowance including the enhanced rate of Medical Allowance shall be discontinued.

The expenditure on account of the revised rate of Medical Allowance sanctioned herein shall be debitable to the respective Head of Account from which the Govt. employees, pensioners including family pensioners drew their salaries and pension respectively.
