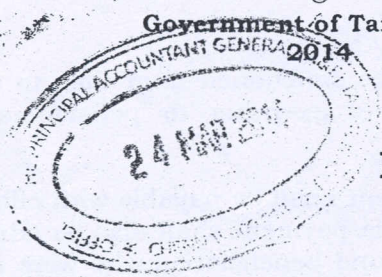

Exgratia payment to families of deceased Contributory Provident Fund/
non - pensionable establishment beneficiaries - Revision - ordered.

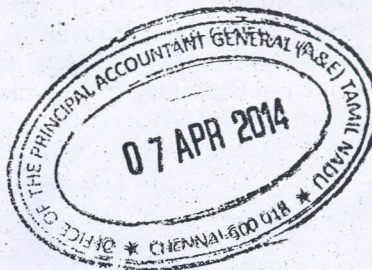

3. From the Principal Secretary/Chairman and Managing Director/ Tamil Nadu Generation and Distribution Corporation Limited & Tamil Nadu Electricity Board Limited and Chairman/ Tamil Nadu Transmission Corporation Limited D.O Lr.No.85876/A183/2013-1 Dated.8.01.2014.

ORDER:

In the Government order first read above, orders have been issued revising the amount of basic ex-gratia from Rs.150/- to Rs.605/- with effect from 1.11.1997 following the orders issued by Government of India. The Government of India in its Memorandum second read above has now revised the exgratia amount from Rs.605/- to Rs.645/- with effect from 04.06.2013 to the category of Widows and dependent children of the deceased Contributory Provident Fund beneficiary.

2) In pursuance to the above orders of Government of India, the Principal Secretary/Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited and Tamil Nadu Electricity Board Limited in the reference third read above, has requested the Government to issue necessary orders revising the exgratia amount to the families of the deceased Contributory Provident Fund / non-pensionable establishment beneficiaries. The Government after careful consideration, has decided to accept the proposal of the Principal Secretary/Chairman & Managing Director, Tamil Nadu Generation and Distribution Corporation Limited and Tamil Nadu Electricity Board Limited and accordingly order to revise the existing ex-gratia amount of Rs.605/- to Rs.645/- per month with effect from 04.06.2013 to the Widows and dependent children of the deceased Contributory Provident Fund beneficiaries / non-pensionable establishment beneficiaries.



3) Dearness Allowance as may be sanctioned from time to time on the sums of enhancement amount of ex-gratia to pensioners/family pensioners as admissible to them.

4) The arrears of ex-gratia payment shall be payable with effect from 04.06.2013. Lifetime arrears of ex-gratia payment shall also be admissible in respect of Contributory Provident Fund beneficiaries who were alive on 04.06.2013 and died subsequent to that date for the period from 04.06.2013 to the date of death.

5) The Pension Pay Officer, Chennai, The Treasury Officer/Sub-Treasury Officers concerned are requested to revise the ex-gratia accordingly and pay the arrears accrued to the Widows and dependent children of the deceased Contributory Provident Fund beneficiaries/ non-pensionable establishment beneficiaries with effect from 4.06.2013.

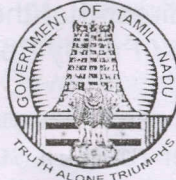

PENSION - Dearness Allowance to the Pensioners and Family Pensioners - Revised rate admissible from 1st January 2014 - Orders - Issued.

READ :

1. G.O.Ms.No.403, Finance (Pension) Department, dated: 10.10.2013.
2. G.O.Ms.No.96, Finance (Allowances) Department, dated:03.04.2014.
3. Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare, Office Memorandum F.No.42/10/2014, dated: 09.04.2014.

ORDER :

In the Government Order first read above, orders were issued sanctioning the revised rate of Dearness Allowance to the State Government pensioners / family pensioners as detailed below:-

Date from which payable	Revised rate of Dearness Allowance (per month)
With effect from 1st July, 2013	90% of Pension / Family Pension

2. The Government of India, in its Office Memorandum third read above has enhanced the Dearness Allowance payable to its pensioners / family pensioners from 90% to 100% with effect from 1st January, 2014.

3. Following the orders issued by the Government of India, the Government has now decided to sanction one additional instalment of Dearness Allowance at 10% to the Pensioners / Family Pensioners of the State with effect from 01.01.2014. Accordingly, the Government sanction the revised rate of Dearness Allowance to the State Government Pensioners / Family Pensioners as indicated below:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1st January, 2014	100% of Pension / Family Pension

4. The Government also direct that the increase in Dearness Allowance shall be paid in cash to the Pensioners / Family Pensioners with effect from 01.01.2014.

5. While arriving at the revised Dearness Allowance, fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise. It will be the responsibility of the Pension Disbursing Authority including Public Sector Banks etc. to calculate the quantum of Dearness Allowance payable in each individual case.

6. Pending formal authorisation by the Accountant General, the revised Dearness Allowance shall be paid straightaway by the Pension Pay Officer, Chennai-6, Treasury Officers and Public Sector Banks concerned.

7. This order will apply to the following categories of pensioners:-

- i) Government pensioners, Teacher pensioners of aided and local body educational institutions and other pensioners of local bodies.
- ii) The State Government employees who had drawn lumpsum payment on absorption in Public Sector Undertaking / Autonomous body / Local body / Co-operative institution and have become entitled to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount.
- iii) Present and future family pensioners; In the case of divisible family pensioners, Dearness Allowance shall be divided proportionately.
- iv) Former Travancore-Cochin State pensioners drawing their pension on 1st November, 1956 in the Treasuries situated in the areas transferred to Tamil Nadu State on that date, i.e. Kanniyakumari District and Shencottah taluk of Tirunelveli District.
- v) Pensioners who are in receipt of special pensions under Extra-ordinary Pension Rules, Tamil Nadu and Compassionate Allowance.

8. The expenditure on Dearness Allowance payable to the Pensioners shall be debited to:

" 2071. Pension and Other Retirement Benefits - 01. Civil - 101. Superannuation and Retirement Allowances - I. Non-Plan - AC. Dearness Allowance to Pensioners - 03. Dearness Allowance (D.P. Code 2071 01 101 AC 0306)"

The expenditure on Dearness Allowance payable to the Family Pensioners shall be debited to

" 2071. Pension and Other Retirement Benefits - 01. Civil - 105. Family Pensions - I. Non-Plan - AC. Dearness Allowance to Family Pensioners of Tamil Nadu Government - 03. Dearness Allowance (D.P. Code 2071 01 105 AC 0308) "

9. Orders regarding sanction of Dearness Allowance to the widows and children of the deceased Contributory Provident Fund / Non Pensionable Establishment beneficiaries of State Government and the former District Board who are drawing ex-gratia will be issued separately.

10. The increased expenditure due to the sanction of Dearness Allowance in this order is allocable among the successor States as per the provisions laid down under the State Reorganization Act, 1956.
