Sub: Grant of Dearness Allowance to pensioners of Karnataka State with effect from 1-1-2012 to 31-03-2012.

I am to invite a reference to Government of Karnataka, Finance Department Order No.FD (Spl) 17 SRP 2012 dated 14-05-2012, and to authorize you to pay the increase in DA from the existing 69.5% to 76.75% of basic pension/family pension to the State Government pensioners/family pensioners including the pensioners/family pensioners of the Aided Educational Institutions whose pension/family pension is paid out of Consolidated Fund of the State with effect from 1-1-2012 to 31-03-2012.

This order shall not be applicable to the pensioners, who were drawing immediately before retirement, (i) payin the FNJPC (state judicial officers) and (ii) pay in the UGC, AICTE and ICAR Scales of pay and who retired on or after 1-1-2006. Separate Orders will be issued in respect of these pensioners.

GOVERNMENT ORDER NO. FD 17 SRP 2012, BANGALORE, DATED 14th MAY 2012

Government are pleased to sanction increase in the rates of Dearness Allowance payable in the 2007 pay scales from the existing 69.5% to 76.75% of the basic pay to the State Government employees with effect from 1st January 2012 and upto 31st March 2012. The Dearness Allowance of 76.75% admissible with effect from 1st January 2012 is merged with basic pay in the 2012 revised pay scales with effect from 1st April 2012.

- 2. The increase in Dearness Allowance admissible under this order is payable in cash.
- 3. These orders will apply to the full time Government employees, employees of Zilla Panchayats, work charged employees on regular time scales of pay, full time employees of aided educational Institutions and Universities who are on regular time scales of pay.
- 4. For the purpose of this order, the term 'Basic Pay' means, pay drawn by a Government Employee in the scale of pay applicable to the post held by him and includes:
 - a. Stagnation increment, if any, granted to him above the maximum of the scale of pay.
 - b. Personal Pay, if any, granted to him under sub-rule (3) of Rule 7 of the Karnataka Civil Services (Revised Pay) Rules, 2007.
- 5. Basic Pay shall not include any emoluments other than those specified above.

- 6. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
- The Dearness Allowance will be shown as a distinct element of remuneration and will 7. not be treated as pay for any purpose.
