Sub: Revision of pension of pre 1.7.2009 pensioners-fixation of pension-Teaching Staff of Medical Education Department who retired prior to 1.4.1990- clarification orders-endorsed-reg

As per GO cited 2nd, Government have issued orders revising pension/family pension in respect of State Service pensioners/family pensioners. The Pension Disbursing Authorities are entrusted with the revision work of pre 1.7.2009 pensioners. Government in GO cited 3rd clarified that while fixing revised pension/family pension in accordance with the principle laid down in para 3 of the Government Order read 2nd above, Pension Disbursing Authorities shall take into account the corresponding revised scale of pay given in the Schedule of posts & Scale of pay in Annexure XII of Pay Revision orders read 1st above and subsequent modifications thereto. Further, it was clarified that in respect of pensioners coming under the purview of Para 3.9 of GO cited 3rd, pension/family pension shall be fixed based on the corresponding scale of pay indicated in Schedule III of GO dated 28.2.2011.

In partial modification to the orders cited 2nd and 3rd above, now in GO(P) No.492/2012/Fin dated 10.09.2012, Government have ordered that pension/family pension in respect of Teaching Staff of Medical Education Department who retired

prior to 1.4.1990, the pension will be revised taking into account the scale of pay shown in the table below.

Designation	Scale of pay
Associate Professor	Rs.36140-49740
Professor	Rs.42640-58640
Principal/Director	Rs.44640-58640

These orders will have effect from 1.7.2009. The pensioners are eligible for Dearness Relief at the rate applicable to State Service pensioners/family pensioners.

All Pension Disbursing Authorities are directed to act accordingly and disburse arrears, if any due. Consequent on issuance of these orders, clarifications otherwise issued by this office in individual cases shall be treated as withdrawn. A copy of GO(P) No.492/2012/Fin dated 10.09.2012 is enclosed for reference.

ORDER

In the Government orders read above, orders were issued revising pension of the state Government pensioners. In the representation submitted by the teaching staff of Medical Education Scheme who retired prior to 01.04.90, it is pointed out that they are deprived of the benefit of 'one rank one pension' solely for the reason that central scales were introduced subsequent to their retirement.

After having examined the matter in detail, Government are pleased to order that while fixing 'one rank one pension ' in respect of the teaching staff of Medical Education Department who retired prior to 1.04.90, the pension will be revised taking into account the scale of pay as shown in the table below as the corresponding revised scale, based on the scale of pay of their counter parts in other medical education departments in Pay Revision 2004.

Associate Professor	20700-26600	36140-49740
Professor	23200-31150	42640-58640
Principal/ Director	25400-33100	44640-58640

They are eligible for State Dearness Relief only. These orders will have effect from 01/07/2009.
