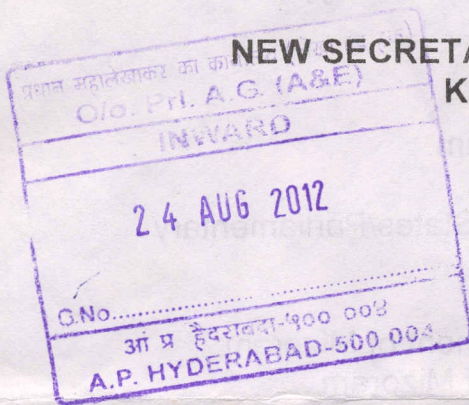

Subject: Interpretation of dependency criterion for grant of two family pension under CCS (Pension) Rules, 1972.

Consequent upon the implementation of 6th CPC and in line with O.M.No.1/11/2011-P & P(W) (E) dt. 30.11.2011 issued by Government of India, Department of Pension and Pensioner's Welfare, New Delhi the Governor of Mizoram hereby decided that family pension admissible to a beneficiary in respect of one deceased employee/pensioner is not to be counted as income for the purpose of determination of eligibility for another family pension which is admissible in connection with another deceased employee/pensioner. These O.M shall be deemed to have taken effect from the 1st January, 2009.



However, grant of family pension to childless widow of a deceased Central Government employees after her re-marriage shall not be extended to the family pensioners of Government of Mizoram at this juncture.
