Sub: Revision of pension of pre 1.7.2009 pensioners-fixation of pension-non UGC Principals- clarification orders-endorsed-reg

As per GO cited 2nd, Government have issued orders revising pension/family pension in respect of State Service pensioners/family pensioners. The Pension Disbursing Authorities are entrusted with the revision work of pre 1.7.2009 pensioners. Government in GO cited 3rd clarified that while fixing revised pension/family pension in accordance with the principle laid down in para 3 of the Government Order read 2nd above, Pension Disbursing Authorities shall take into account the corresponding revised scale of pay given in the Schedule of posts & Scale of pay in Annexure XII of Pay Revision orders read 1st above and subsequent modifications thereto. As per these orders, a pensioner who was holding the post of Professor Grade I (non UGC) at the time of retirement and whose pension with effect from 1.4.2005 was fixed in the scale of pay of Rs.16650-23200, the pension/family pension with effect from 1.7.2009 is to be fixed in the scale of pay Rs. 29180-43640.

In partial modification to the orders cited 2nd and 3rd above, Government as per GO cited 4th have clarified that pension/family pension in respect of 1st Grade Professors of Arts and Science Colleges under non UGC category shall be revised by

taking into account the scale of pay of Rs.36140-49740 as corresponding revised scale.

Now in GO(P) No.372/12/Fin dated 4.7.2012 Government have clarified that pension/family pension in respect of Principals of Arts and Science Colleges, Sanskrit Colleges and Training Colleges under non UGC category shall be revised by taking into account the scale of pay of Rs.40640-57440 as corresponding revised scale as in the case of Principals in Music Colleges. In the case of Principals of Physical Education Colleges under non UGC category, pension/family pension shall be revised considering the scale of pay of Rs.36140-49740 as corresponding revised scale as in the case of Principals in Arabic Colleges.

Hence, all Pension Disbursing Authorities are directed to act accordingly and disburse arrears, if any due. Consequent on issuance of these orders, clarifications otherwise issued by this office in individual cases shall be treated as withdrawn. A copy of GO dated 4.7.2012 is enclosed for reference.

ORDER

As per Government Order read 3rd paper above, Pension/ Family pension in respect of State Service Employees and Teachers were revised based on the scales of pay which came into force with effect from 01.07.2009 vide Government orders read 1st and 2nd above. The corresponding revised scales of certain posts under non UGC category in the Collegiate Education are not included in the Annexure XII of Government Orders read 1st and 2nd above. Many representations have been received requesting to revise the pension of the above posts reckoning revised scales sanctioned to their counter parts in other Colleges.

After having examined the matter in detail, Government are pleased to clarify that Pension/ Family pension in respect of Principals of Arts and Science Colleges, Sanskrit Colleges and Training Colleges under non UGC category shall be revised by taking into account the scale of pay of ₹ 40640-57440 as corresponding revised scale as in the case of Principals in Music Colleges. In the case of Principals of Physical Education Colleges under non UGC category Pension/ Family Pension

shall be revised considering the scale of pay of ₹ 36140-49740 as corresponding revised scale as in the case of Principals in Arabic Colleges.

The Government order read as 3rd paper above stands modified to this extent.
