As per GO cited 1st, pension and other related benefits of those coming under UGC/AICTE/MES Schemes were revised with monetary benefit of pension revision from 1.3.2010. Now, as per GO cited 2nd, Government have sanctioned arrears consequent on revision with effect from 1.7.2009.

Applicability of the GO:

These orders are applicable to those who come under UGC/AICTE/MES Schemes.

Pre 1.1.2006 pensioners/family pensioners:

Pre 1.1.2006 pensioners/family pensioners in respect of whom revised pension/family pension has been authorised by this office with effect from 1.3.2010, arrears on revised pension/family pension may be paid retrospectively with effect from 1.7.2009. The rate of basic pension/family pension with effect from 1.7.2009 will be the rate eligible as on 1.3.2010.

Post 1.1.2006 pensioners/family pensioners:

In the case of those who retired/expired while in service on or after 1.1.2006 but before 28.2.2010 and in respect of whom revised pension/family pension has been authorised by this office with effect from 1.3.2010, arrears on revised pension/family pension may be paid retrospectively with effect from 1.7.2009 or from the date following the date of retirement/death of the employee whichever is later.

Arrears contemplated in the GO referred (2) above may be disbursed without waiting for further authorisation from this office in individual cases.

- 1. Consequent on revision of scale of pay, Pension and other related benefits of those coming under UGC/AICTE/Medical Education Scheme were revised vide Government Order read as 1st paper above with monetary benefit from 01.03.2010.
- 2. Several representations have been received by Government requesting to grant arrears of pension, on account of revision ordered in the Government Order dated 07.05.2011, from the date on which revised scale of pay came in to force.
- 3. Government have examined in detail the various aspects involved in this matter. Eventhough scales under Central schemes are revised once in 10 years, as a practice State pension revision is being extended to pensioners covered under Central schemes each time when pension is revised in respect of State

o1.04.2005 has also been extended to them vide Government Order read as 2nd paper above. Since the State pension revision was ordered with effect from 01.07.2009, Government are pleased to sanction the arrears consequent on revision of pension vide Government Order read 1st paper above with effect from 01.07.2009.
