OFFICE MEMORANDUM

Subject: - Revision of pension of pre-2006 pensioners-reg.

The undersigned is directed to say that in continuation to instructions contained in this Departments' Office Memorandum No. Fin.(Pen)A(3)-1/09-Part-II dated 14th October,2009 the Governor,Himachal Pradesh, is pleased to order that the pension of pre-2006 pensioners as revised w.e.f.1.1.2006 in terms of para 4.1 or para 4.2 of the aforesaid OM dated 14.10.2009, would be further stepped up to 50% of the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale from which the pensioner had retired, as arrived at with reference to the fitment tables attached to H.P.Civil Services(Revised Pay)Rules,2009 notified vide No. Fin-(PR) B (7)-1/2009 dated 26.08.2009.

- 2. The normal family pension in respect of pre-2006 pensioners/family pensioners as revised w.e.f. 1.1.2006 in terms of para 4.1 or para 4.2 of the aforesaid OM dated 14.10.2009 would also be further stepped up to 30% of the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale in which the Government servant had retired, as arrived at with reference to the fitment tables attached to H.P.Civil Services (Revised Pay) Rules, 2009 notified vide No. Fin-(PR) B (7)-1/2009 dated 26.08.2009.
- 3. A revised concordance table (Annexure-I) of the pre-2006 and post 2006 pay scales/pay bands indicating the pension/family pension (at ordinary rates) payable under the above provisions is enclosed to facilitate payment of revised pension/family pension.
- 4. The pension so arrived at in accordance with para 1 above and indicated in Col.7 of Annexure will be reduced pro-rata, where the pensioner had less than the maximum required service for full pension as per rule 49 of the CCS (Pension) Rules, 1972 as applicable before 1.1.2006 and in no case it will be less than Rs.3500/- p.m.
- 5. The family pension at enhanced rates (under Rule 54(3) (a) (i) of the CCS (Pension) Rules, 1972) of pre-2006 pensioners/family pensioners revised w.e.f., 1.1.2006 in terms of para 4.1 of this Department's O.M. No. dated 14.10.2009 would be further stepped up in the following manner:
 - (i) In the case of Government servants who died while in service before 1.1.2006 and in respect of whom enhanced family pension is applicable from the 1.4.2013, the enhanced family pension will be stepped up to 50% of the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale in which the Government servant had died, as arrived at with reference to the fitment tables attached to H.P.Civil Services (Revised Pay) Rules, 2009 notified vide No. Fin-(PR) B (7)-1/2009 dated 26.08.2009.

- 6. In case the pension consolidated pension/family pension/enhanced family pension calculated as per para 4.1 of OM 14.10.2009 is higher than the pension/family pension calculated in the manner indicated above, the same (higher consolidated pension/family pension) will continue to be treated as basic pension/family pension.
- 7. All other conditions as given in O.M. No. Fin.(Pen)A(3)-1/09-Part-II, dated 14.10.2009 shall remain unchanged.
- 8. These orders will take effect from 1.04.2013. There will be no change in the amount of revised pension/family pension paid during the period 1.1.2006 and 31.3.2013 and, therefore, no arrears will be payable on account of these orders for that period.
- 9. It shall be the responsibility of the Head of the Department/office etc. from which the Government servant had retired or where he was working prior to his demise, to revise the pension/family pension of all pensioners/family pensioners with effect from 01-04-2013 in accordance with the provisions mentioned in Para 1 & 2 above and to get revised Pension Payment Order (PPO), issued by the Accountant General (A&E), H.P. Action to revise pension/family pension in terms of these provisions shall be initiated *suo-motu* by the concerned Head of Department/Office. It is emphasized that the Pension Sanctioning Authority, in no case, will ask the pensioner/family pensioner to surrender his/her original Pension Payment Order (PPO) for issuing revised authority.
- 10. The Heads of Department/Offices and Accountant General (A&E), H.P. will take immediate action for revision of pension in terms of these orders.
