

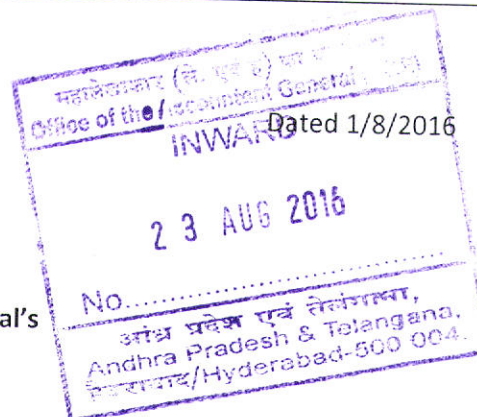

**OFFICE MEMORANDUM**

**Subject: Payment of Dearness Relief to Nagaland Government Pensioners/Family Pensioners.**

The undersigned is directed to refer to this department's notification of even number dated 26<sup>th</sup> February, 2016 and to say that the Governor of Nagaland is pleased to sanction Dearness Relief to Pensioners of the Government of Nagaland and Family Pensioners from the existing rate of 119% to 125% with effect from 01.01.2016.

2. Payment of Dearness Relief involving of a fraction of rupee shall be rounded off to the next higher rupee.
3. Other provision governing Dearness Relief to the Pensioners such as regulation of Dearness Relief on re-employment, regulation of Dearness Relief where more than one pension is drawn, etc. shall remain unchanged.
4. Authorized Public Sector Banks, Treasuries/Sub-Treasuries are requested to arrange for payment of Dearness Relief to the pensioners on the basis of the above instruction.
5. The Accountant General, Nagaland, is requested to circulate this O.M. to all State Accountants General so that Pensioners of the Government of Nagaland drawing pension under their jurisdiction may be authorized for payment of this relief at the earliest.

1. The Government of Nagaland had vide its O.M. No. FIN/ ROP/REL-8/87 (Vol-I) dated 26.10.2010 authorized the Public Sector Banks, Treasuries/Sub-Treasuries to release payment of Dearness Relief to the Nagaland State Government Pensioners/Family Pensioners as and when sanctioned by the Government of India without any further order from the State Government or authorization from the Accountant General, Nagaland. This was done in order to avoid delay in payment of Dearness Reliefs.
