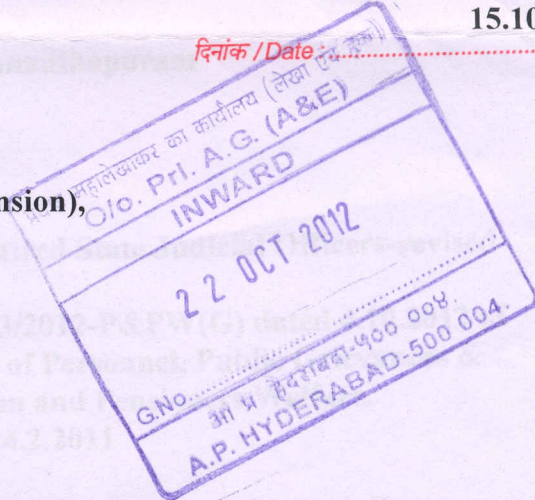

Sub: Grant of Dearness Relief to the retired State Judicial Officers-revised rate effective from 1.7.2012-reg

- Ref: 1. Office Memorandum F.No.42/13/2012-P&PW(G) dated 4.10.2012 of Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension and Pensioners Welfare.
2. GO(Ms) 55/2011/Home dated 24.2.2011

As per OM cited 1<sup>st</sup>, the Dearness Relief payable to Central Government pensioners/family pensioners has been enhanced from the existing rate of 65% to 72% with effect from 1.7.2012.

Government of Kerala as per orders cited 2<sup>nd</sup> have extended the benefit of increase in Dearness Relief sanctioned to Central Government pensioners/family pensioners to the pensioners/family pensioners coming under the category of State Judicial Officers without further orders from the State Government.

Hence, you are requested to honour the claim for enhanced Dearness Relief at the rate of 72% with effect from 1.7.2012, preferred by pensioners/family pensioners coming under the category of State Judicial Officers in respect of whom pension/family pension has been revised based on replacement scale came into force with effect from 1.1.2006.
