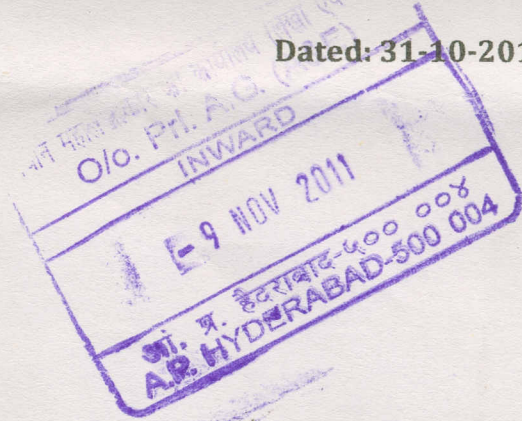

**Sub: Grant of Dearness Allowance to pensioners of Karnataka State with effect from 1-7-2011.**

I am to invite a reference to Government of Karnataka, Finance Department Order No. **FD (Spl) 07 CPP 2011 dated 17-10-2011**, read with corrigendum No. **FD (Spl) 7 CPP 2011 dated 18-10-2011**, and to authorize you to pay the increase in DA from the existing **62.5%** to **69.5%** of basic pension/family pension to the State Government pensioners/family pensioners including the pensioners/family pensioners of the Aided Educational Institutions whose pension/family pension is paid out of Consolidated Fund of the State **with effect from 1-7-2011**.

This order shall not be applicable to the pensioners, who were drawing immediately before retirement, (i) pay in the FNJPC (state judicial officers) and (ii) pay in the UGC, AICTE and ICAR Scales of pay and who retired on or after 1-1-2006. Separate Orders will be issued in respect of these pensioners.


**ORDER NO. FD (Spl) 07 CPP 2011**  
**BANGALORE, DATED 17<sup>th</sup> OCTOBER 2011**

Government are pleased to sanction with effect from 1<sup>st</sup> July 2011 further increase in the rates of Dearness Allowance from the existing 62.5 % to 69.5% of basic pension/family pension to the State Government pensioners/family pensioners and pensioners/family pensioners of the aided educational institutions whose pension/family pension is paid out of the Consolidated Fund of the State.

This order shall not be applicable to pensioners who were drawing immediately before retirement pay in the UGC,AICTE and ICAR scales of pay and who retired on or after 1<sup>st</sup> July 2005. Separate Orders will be issued in respect of these pensioners.

The payment on account of the increase in dearness allowance as per this order involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.


