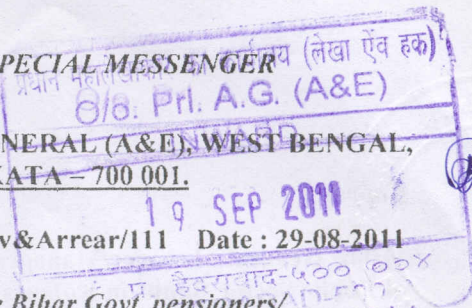

Subject : (i) Grant of Dearness Relief to the Bihar Govt. pensioners/
family pensioners on their un-revised pension/family pension with effect
from 01-07-2009, 01-01-2010 and 01-07-2010; and
(ii) Payment of 3rd instalment of arrears of pension with effect from 01-04-2007 to
31-08-2009 to the Bihar Govt. pensioners/family pensioners.

In continuation to this office circular No. Pen. Co-ordn./Bihar/Vol.- VIII/DR/110 dated 26-10-2009, this is to state that the Govt. of Bihar in their FD Resolution No. 3A-3-Allowance-01/2009 - 2191 dated 11-03-2011 have sanctioned dearness relief to their pensioners/family pensioners whose pension/family pension have not been revised in the light of Govt. of Bihar FD Resolution No. B.-27/Pay Co.-137/2008-820 dated 23-09-2009 (circulated vide No. Pen. Co-ordn./Bihar/Vol.- VIII/Revision/185 dated 18-03-2010) at the rate and from the date as under :-

Date of effect	Rate of Dearness Relief per month	including Dearness Pension/Dearness Family Pension
01-07-2009	73% of basic pension/family pension	
01-01-2010	87% of basic pension/family pension	
01-07-2010	103% of basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction less than 50 paise may be ignored.

3. Persons appointed by minister or persons getting minister-level facilities will also be paid dearness allowance in cash at the above mentioned rate.

4. So far as application of this order in respect of the retired employees of the Patna High Court/Bihar Legislative Assembly/Bihar Legislative Council is concerned, necessary orders will be issued separately by the respective secretariat/office after obtaining the concurrence of the Chief Justice, Patna High Court/Speaker, Bihar Legislative Assembly/Chairman, Bihar Legislative Council, Bihar, Patna.

5. Besides, in continuation to this office circular No. Pen. Co-ordn./Bihar/Vol.- VIII/Arrear/180 dated 03-12-2010, this is to state that the Govt. of Bihar in their Order No. 1499/B dated 20-06-2011 has stated that the third and last instalment (i.e. 45%) of arrears of pension with effect from 01-04-2007 to 31-08-2009, payable in the year 2011-12, shall be paid immediately.

6. Incidentally, it may be mentioned that this circular is issued to other Accountants General just to remind them the applicability of this order to the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules.

7. Having been authorised by the Accountant General (A&E)-II, Bihar in their letter Nos. Pen-IX-Spl. Seal Authority No. 06 dated 01-04-2011 and Pen-IX-Spl.seal Authority No. 347 dated 21-07-2011, it is requested to make necessary arrangement for payment of dearness relief @ 73%, 87% and 103% with effect from 01-07-2009, 01-01-2010 and 01-07-2010 respectively to all eligible Bihar Govt. pensioners/family pensioners as well as West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules on their pension/family pension and dearness pension/dearness family pension after proper adjustment. It is also requested to make necessary arrangements for payment of said 45% of arrears immediately, if not already paid.

8. The charges on this account for the pensioners/family pensioners of Govt. of Bihar are debitable to the Govt. of Bihar under the head "8793-I.S.S.A/cs.; Govt. of Bihar etc" and the charges for the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules are debitable to the Govt. of West Bengal under the head "2071-Pension and Other Retirement Benefits".
