RESOLUTION

Sub: Revision of pension / family pension in respect of the pre-2006 and post-2006 pensioner and family pension holders of Odisha Judicial Service.

Government had extended the benefit of revision of pension/family pension in respect of the pre-2006 and post-2006 pensioner and family pension holders of Odisha Judicial Service vide F.D. Resolution No.40733/F dated 22.9.2010.

The benefit of reduction of qualifying service from 33 years to 20 years were provided vide above said Resolution to Odisha Judicial Service Officers w.e.f. 2.9.2008.

Similarly, they were entitled to commute for a lump-sum payment up to 40% of their pension w.e.f. 1.1.2006 with restoration period of fifteen years in accordance with revised commutation table appended to the said Resolution No.40733/F dated 22.9.2010.

In order to comply with the direction of the Hon'ble Apex Court in I.A. case No.244 in writ petition (C) No.1022/1989 dated 27.7.2010 accepting the recommendations made by Justice E. Padmanabhan Committee for all judicial officers, the Government after careful consideration have been pleased to modify the paragraphs 6(3) and 13 of the Resolution No.40733/F dated 22.9.2010 as below:

6(3) The revised provisions for calculation of pension in para 6(2) of Resolution No.40733/F dated 22.9.2010 shall come into force w.e.f. 1.1.2006 instead of 2.9.2008 and shall be applicable to the State Judicial Officers retiring on or after 1.1.2006.

## 13. <u>Commutation of Pension</u>

(i) Officers of State Judicial service shall be entitled to commute up to 50% of the pension w.e.f. 1.1.2006 which shall be restored on expiry of 15 years from the date on which the amount of pension was reduced on account of commutation.

- ii) The revised table of commutation value for pension applicable in respect of post-2006 pensioners as given in Annexure-1 of the F.D. Resolution No.3653/F dated 19.1.2009 will be used for all commutation of pension which become absolute after the issue of this resolution.
- iii) In respect of cases where commutation has already been allowed earlier up to 40% of the pension, option shall be offered to commute the additional amount of pension that has become commutable in terms of this resolution. On exercising of such an option by the pensioner, the revised table of commutation value for pension will be used for the commutation of additional commuted amount of pension. Such additional commuted value of pension will be sanctioned in his / her favour which shall be restored on expiry of 15 years from the date of sanction of the additional commuted value of pension.
- iv) The pensioners who could not exercise their option to commute the amount of pension that become additionally commutable on account of retrospective revision of pay / pension according to para 13 of F.D. Resolution 40733/F dated 22.9.2010 shall also exercise their options to commute the amount of pension up to 50% of their pension that has become additionally commutable. On exercising of such an option by the pensioner, the revised table of commutation value for pension will be used for the commutation of additional amount of pension. Accordingly, the provisions of rule 5 and 7 of OCS (Commutation of Pension) Rules, 1992 shall stand modified.
- v) Pensioners opting for additional value of commutation of pension shall exercise their options latest by three months from issuance of this resolution.

All other paragraphs stated in Resolution No.40733/F dated 22.9.2010 shall remain unaltered.

ORDER – Ordered that this Resolution be published in the next issue of the Odisha Gazette.
