
I am directed to refer to Para-2 (ii) of letter No. 1/3(18)94-2FR-II, dated 17-3-1997 vide which following rates of family pension were further revised w.e.f. 1-1-1986:-

Sr. No.	Basic pay per month	Rate of family pension per month inclusive of dearness relief upto average CPI 608.
1.	Not exceeding Rs. 1500/-	30% of basic pay subject to a minimum of Rs. 300/- (and Rs. 375/- w.e.f. 1-1-1995)
2.	Exceeding Rs. 1500/-	25% of basic pay subject to a minimum of Rs. 450/- and maximum of Rs. 1250/-

2. It has been brought to the notice of the Finance Department that family pension in some cases was already higher than Rs. 1250/- Therefore. State Government has decided that family pension of such family pensioners would not be reduced and they will continue to draw family pension at the same old rate.

3. These instructions may be brought to the notice of all concerned for strict compliance.


