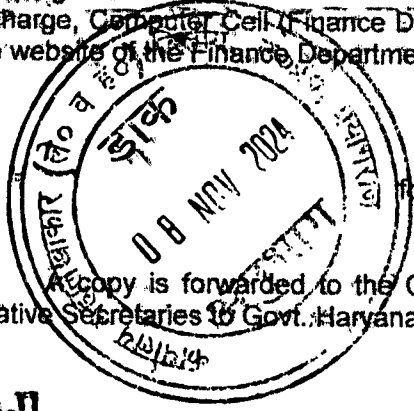



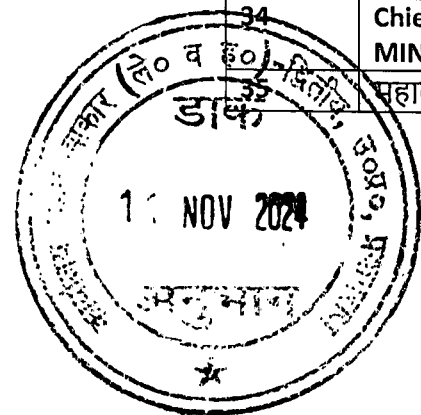

In view of the above, for Para 2.3 and para 10 of the said instructions, the following is further clarified :

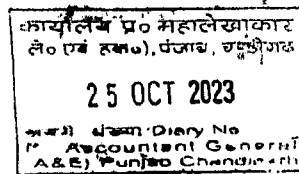

- **Para 2.3** -According to rule 3.27 of Punjab CSR Vol-I Part-1, the superannuation age of disabled government employees (other than Group D employees) shall be sixty years.
  - **Para 10** For the payment of Ex-Gratia grant, the categories mentioned in para 10 of these instructions, shall be read as under :-

The revised rate of Ex-Gratia grant shall be admissible from prospective effect only, i.e. for the employee dies on or after 01.07.2021. The revised rate shall also be applicable to the employees who are covered under New Pension Scheme. The compliance of provisions contained in the Pb.CSR, Vol. II shall be adhered to.



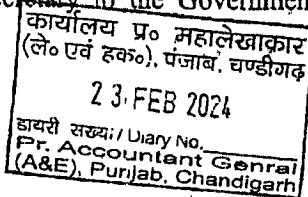

The amount to be deposited shall be verified by the PSA. Thereafter, the pensioner shall deposit this amount (in lump sum) in the Government Treasury through challan by 31.7.2023.
- b) The Pension Sanctioning Authority (PSA) will send the pension case to the Accountant General (A&E) within two weeks to issue the revised authority.
- c) Neither Government will charge any interest which would have accrued to the pensioner nor will pay any interest to the pensioner in this regard.
- d) A formal communication is being sent to the Principal Accountant General (A&E) Punjab for necessary instructions to their Officers/Officials to expeditiously dispose of the reference being made by PSA.
- e) Those pensioners whose pension cases (for revised commuted value of pension) are pending in the Accountant General's office, can also opt for this option.

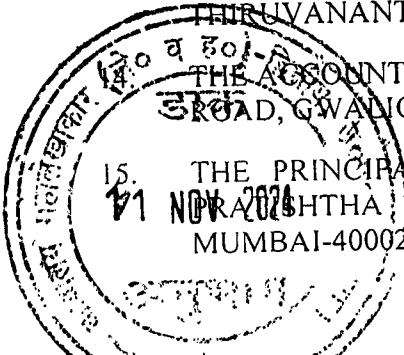



**Sub:- Sanction of Dearness Relief (T.I) @ 3% enhancing the existing rate from 50% to 53% in favour of the State Government pensioners/ family pensioners with effect from 01.07.2024.**


Government of India have enhanced Dearness Relief admissible to the Central Government pensioners/ family pensioners from existing rate of 50% to 53% of the basic pension family pension (including additional pension/ family pension) with effect from 01.07.2024 vide Cabinet decision on 16.10.2024.

2. In the meantime, one dose of Dearness Allowance @3% has been sanctioned in favour of the State Government employees enhancing Dearness Allowance from 50% to 53% with effect from 01.07.2024 vide Finance Department Office Memorandum No 29310/F., dated 22.10.2024.
3. After careful consideration of the matter, State Government have been pleased to release, the additional dose of Dearness Relief (T.I) @3% enhancing the same from the existing rate of 50% to 53% on the revised basic pension/ family pension and provisional pension with effect from 01.07.2024 in favour of State Government pensioners/ family pensioners.
4. The additional dose of Dearness Relief shall also be admissible on additional basic pension/ additional family pension available to the old pensioners/ family pensioners based on their age as indicated in this Department O.M. NO.28300/F dated 23.09.2017.

For the purpose of this Office Memorandum

- i. Pension/ family pension in the case of the pre-01.01.2016 retirees and where family pension was due prior to 01.01.2016 means the revised basic pension/ revised basic family pension as the case may be in terms of Finance Department Office Memorandum No.28300/F dated 23.09.2017.
  - ii. Also, in the case of pensioners who have retired after 01.01.2016 or where family pension is sanctioned for the first time after 01.01.2016 the pension/ family pension means the basic pension / basic family pension, as the case may be sanctioned on retirement/death.
5. The additional dose of Dearness relief shall also be admissible to the pensioners/ family pensioners of Non-Government Aided Educational Institutions including Primary Schools under School and Mass Education Department and Non-Government Aided Educational Institutions under Higher Education Department.
  6. Payment of Dearness Relief (T.I) involving fraction of a rupee shall be rounded off to the next higher rupee.
  7. Other provisions governing grant of Dearness Relief (TI) to Pensioners, such as regulation of Dearness Relief during employment/ re-employment and regulation of Dearness Relief where more than one pension is drawn will remain unchanged.

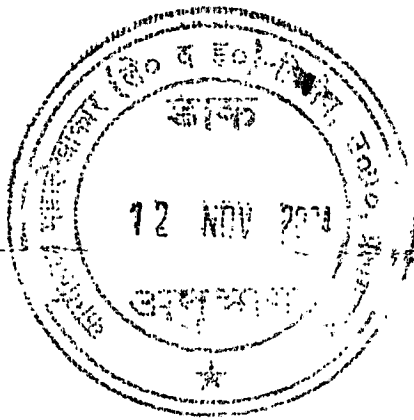



In the Government Order read above, orders were issued sanctioning revised rate of Dearness Allowance to State Government employees as detailed below:-

2. Hon'ble Chief Minister has made an announcement that Dearness Allowance payable to State Government employees shall be enhanced from 50% of basic pay to 53 % of basic pay with effect from 01.07.2024. Accordingly, Government sanction the revised rate of Dearness Allowance by enhancing 3% as indicated below:-

Date from which payable	Rate of Dearness Allowance [per month]
[1]	[2]
01-07-2024	53 per cent of Basic Pay

3. The arrears of Dearness Allowance for the months of July 2024 to September 2024 shall be drawn and disbursed by existing cashless mode of Electronic Clearance System (ECS). While working out the revised Dearness Allowance, fraction of a rupee shall be rounded off to next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

4. The Government also direct that the revised Dearness Allowance sanctioned above shall be admissible to full time employees who are at present getting Dearness Allowance and to employees paid from contingencies at fixed monthly rates. The revised rates of Dearness Allowance sanctioned in this order shall not be admissible to part time employees.

5. The revised Dearness Allowance sanctioned in this order shall also apply to the teaching and non-teaching staff working in aided educational institutions, employees under local bodies, employees governed by the University Grants Commission/All India Council for Technical Education scales of pay, the Teachers/Physical Education Directors/Librarians in Government and Aided Polytechnics and Special Diploma Institutions, Village Assistants in Revenue Department, Noon Meal Organisers, Child Welfare Organisers, Anganwadi Workers, Cooks, Helpers, Panchayat Secretaries/Clerks in Village Panchayat under Rural Development and Panchayat Raj Department and other employees drawing pay in the prescribed Level of Pay/Special Time Scale of Pay in the Pay Matrix.

6. The expenditure shall be debited to the detailed head of account "303. Dearness Allowance" under the relevant minor, sub-major and major heads of account.

7. The Commissioner of Treasuries and Accounts, Chennai is requested to issue necessary instructions to all Drawing and Disbursing Officers while presenting the arrear bill on the revised rates of Dearness Allowance sanctioned at para 2 above.

8. The Treasury Officers / Pay and Accounts Officers are requested to make payment of the revised Dearness Allowance when bills are presented if it is found to be in order.
