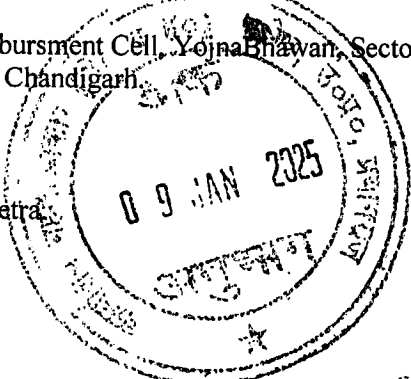

Subject: Issue of stay order on recovery of Commuted Value of Pension--Vacation of Stay order.

Sir/Madam.

I am directed to invite a reference to this office letter No. PCC/Recovery of Commutation/24-25/853-856 dated 21.6.2024, PCC/Recovery of Commutation/24-25/889-914 dated 26.6.2024, PCC/Recovery of Commutation/24-25/990-1015 dated 11.07.2024, PCC/Recovery of Commutation/24-25/1150-1176 dated 12.07.2024, PCC/Recovery of Commutation/24-25/1201 dated 15.07.2024 & Pen.1/Gen-3A/2024-25/Stay order on recovery of CVP/475-539 dated 19.07.2024 regarding *stopping the recovery of commutation of pension from the petitioners till vacation of stay orders in the CWP(s) who have completed 10 year of retirement or above*. In this regard it is intimated that Finance Department, Haryana *in the light of Hon'ble Punjab & Haryana; High Court order(s) dated 27.11.2024 in lead case CWP 9426-2023-Shila Devi and others Vs. State of Punjab and order(s) dated 19.12.2024 in CWP No. 15098 of 2024, Ram Niwas Rohilla and other Vs State or Haryana and others*, vide Memo No. 1/15/2024-1Pension (FD) dated 24.12.2024, has now communicated this office *to resume/revive the recovery of Commuted Value of Pension immediately, which was earlier stopped in compliance of Stay Orders of Hon'ble Punjab and Haryana High Court.*

Further, the recovery of Commuted Value of Pension for intervening period from May 2024 to upto date, (as the case may be) may also be made from the pensioners in equal installment every month alongwith regular recovery of Commuted Value of Pension. The copy of the same is enclosed for your reference and guidance.

As such you are requested to ensure the strict compliance of Finance Department, Haryana instructions entailed in aforesaid Memo dated 24.12.2024 in letter and spirit. The receipt of this letter may be acknowledged.

**Subject: Issue of stay order on recovery of Commuted Value of Pension-
Vacation of Stay order.**

I am directed to invite your attention towards this Department's Memo No. 1/15/2024-1 Pension (FD) dated 13.06.2024, 19.06.2024, 25.06.2024, 26.06.2024, 01.07.2024 and 16.07.2024 wherein in compliance to Interim Order passed by Hon'ble Punjab and Haryana High Court in various CWPs, the necessary directions were issued to stop the recovery of Commuted Value of Pension till the vacation of Stay Orders, from all Pensioners (including petitioners) of State Government who has completed 10 years of retirement or above.

2. Now Hon'ble Punjab and Haryana High Court has disposed of the CWP-15098-2024- Ram Niwas Rohilla and others Vs. State of Haryana and others, regarding Commuted Value of Pension on 19.12.2024. The operative part of above Order reads as under:-

"Learned counsel for the parties are in agreement that the issue(s) and the question(s) of law raised through the instant petition have been considered and decided on 27.11.2024 by a Co-ordinate Bench of this Court in a bunch of petitions in which the lead case was CWP-9426-2023-Shila Devi and others vs. State of Punjab and others.

In the light of the above, we dispose of the present petition in terms of Shila Devi's case (supra) with the only modification that wherever in paragraphs 29 and 30 of the judgment in Shila Devi's case (supra) the reference is to the State of Punjab, the same be read as the State of Haryana".

3. The operative part of Order of referred Judgment dated 27.11.2024 in CWP-9426-2023-Shila Devi and others vs. State of Punjab and others, as mentioned in judgment dated 19.12.2024 in CWP No. 15098 of 2024, Ram Niwas Rohilla and other Vs State of Haryana and others, reads as under:-

Para-31. "Keeping in view facts and circumstances as narrated and discussed in foregoing paras, all the 808 writ petitions are dismissed with no order as to cost. It is clarified that the State is entitled to effect recoveries which were stayed by way of interim orders in the writ petitions. Such recovery however be made in a staggered manner to obviate any hardship to the pensioners".

4. In view of above orders of Hon'ble Punjab and Haryana High Court to effect the recovery of Commuted Value of Pension, you are requested to kindly issue necessary directions to the officers concerned alongwith Pension Disbursing Banks to resume/revive the recovery of Commuted Value of Pension immediately, which was earlier stopped in compliance of Stay Orders of Hon'ble Punjab and Haryana High Court.

5. Further, the recovery of Commuted Value of Pension for intervening period from May 2024 to upto date, (as the case may be) may also be made from the pensioners in equal installment every month alongwith regular recovery of Commuted Value of Pension.



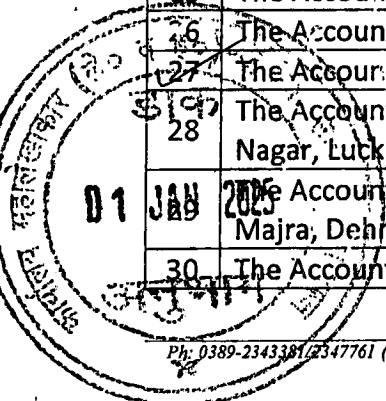

4. Payment of enhanced Dearness Relief should be made in Indian Rupee (INR).


