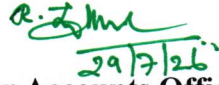

Read 1. O.M.No.1/1(i)/2026-E.II(B) dated 22.04.2026 of the Department of Expenditure, Ministry of Finance, Government of India.

ORDER

As per the Office Memorandum read above, Government of India have enhanced the rate of Dearness Allowance payable to the Central Government employees from 58% to 60% with effect from 01.00.2026. Therefore, the rate of Dearness Allowance / Dearness Relief payable to State Judicial Officers / State Judicial Pensioners /Family Pensioners is ordered to be enhanced from the existing rate of 58% to 60% with effect from 01.01.2026.

2. The arrears of Dearness Allowance / Dearness Relief consequent on this revision shall be paid in cash.
