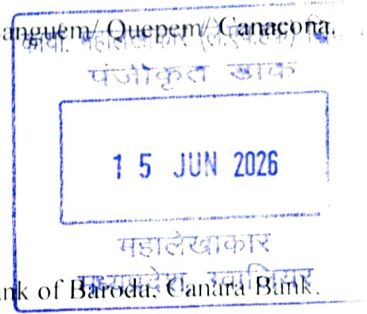

Sub: -Release of an additional installment of Dearness Relief (DR) to Central Government pensioners/family Pensioners revised rate with effective from 01/01/2026.

1. The Under Secretary Finance (R&C), Government of Goa, Department of Finance (Revenue & Control), Secretariat, Porvorim, vide Office Memorandum No.12/3/82-Fin(R&C)/Vol.II/31928 dated 29th May 2026 has adopted the Office Memorandum No. 42/02/2024-P&PW(D)/E-9475 dated 24th April 2026 issued by the Director, Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension & Pensioner's Welfare, New Delhi, regarding release of additional installment of Dearness Relief to Central Government Pensioners/family pensioners – revised rate with effect from 01/01/2026. The copy of the said Office Memorandums are enclosed for information and necessary action.

2. Since the Office Memorandum dated 24/04/2026 is adopted and made applicable to the Goa Government Pensioners and Family Pensioners, I am to authorize you to pay to the Goa Government Pensioners/Family Pensioners enhanced Dearness Relief from the existing rate of 58% to 60% w.e.f 01/01/2026.

The Dearness Relief @ 60% is to be paid to the Pensioners/ family pensioners along with the arrears from 01/01/2026 to 31/05/2026, along with the pension/family pension for the month of June, 2026. It is applicable to the following pensioners.

- (a). Ex-gratia pensioners (Montepio pensioners, pensioners drawing pensions on account of service rendered to Portuguese colonies and institute Ultramarine Pensioners) drawing pensions under C/B/D and E series.
 - (b). Pensao de Sanguie pensioners.
 - (c). Pensioners receiving pension under triple benefit scheme.
 - (d). Recipients of Ex-gratia i.e. Families of deceases pensioners/employees who were governed under EFU.
 - (e). Pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under pension payment series T and E.B.
3. In case of Goa State Government Pensioners drawing pension in Other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension/family pension.
4. This Dearness relief is not applicable to the following class of pensioners.
- a. Pensioners drawing pension, which is granted after Independence for Political consideration (Ex-Rulers).
 - b. Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
 - c. Pensioners of Other States (PAO) Suspense for whom separate orders are applicable.
 - d. M.L.A. Pensioners.
 - e. Freedom Fighter pensioners/family pensioners of Govt. of Goa.
5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
6. Wide publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.

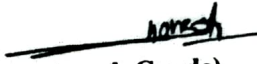

Sub: Release of an additional Installment of Dearness Relief (DR) to Central Government Pensioners/Family Pensioners - Revised rate with effect from 01st January, 2026 -reg.

The undersigned is directed to refer to this Department's OM No.42/02/2024-P&PW(D) dated 8th October, 2025 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/ Family Pensioners shall be enhanced from the existing rate of 58% to 60% of the basic pension/family pension (including additional pension/family pension) w.e.f. 01st January, 2026.

2. These rates of DR will be applicable to all Central Government Pensioners/Family Pensioners including Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates; Railway Pensioners/Family Pensioners; All India Service Pensioners/Family Pensioners; Pensioners who are in receipt of provisional pension and also to those Pensioners/Family Pensioners covered under this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23rd June, 2017 and para 6 of this Department's OM No. 23/3/2008-P&PW(B) dated 11th September, 2017.
3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
4. The offices of Accountant General and authorized Pension Disbursing Banks are requested to arrange payment of Dearness Relief on the basis of these instructions without waiting for any further instructions in view of Comptroller and Auditor General of India's letter No.528-TA,II/34-80-II dated 23rd April, 1981 and Reserve Bank of India's Circular No.GANB No.2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981.
5. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148 (5) of the Constitution of India.
6. This issues in accordance with the Ministry of Finance, Department of Expenditure's O.M. No.1/1(i)/2026-E.II(B) dated 22nd April, 2026.
