- Sub: Grant of Dearness Relief to State Government Pensioners/ Family Pensioners Revised rate effective from 01/07/2018.
- The Government of Goa, Finance (Rev. & Cont.) Department Secretariat, Porvorim, vide letter No. 12/1/2019-Fin(R&C) dated 11/02/2019 have conveyed the sanction for revision of Dearness Relief to the Pensioners/Family Pensioners of employees of Goa Government and its Autonomous Bodies who are in receipt of pension in pre-revised pay structure/scales of 6th Central Pay Commission. The copy of the said Office Memorandum is enclosed for information and necessary action.
- 2. Since the order on relief contained in the above Finance (Expenditure) Department Memorandum are applicable to the employees/ Pensioners and Family Pensioners of State Government and its Autonomous bodies who continue to draw their pay and allowances in the pre-revised scale of pay as per 6th Central Pay Commission and drawing DR at rate of 125%. I am to authorize you to pay employees/Pensioners/Family Pensioners of State Government and its autonomous bodies, the revised rates of Dearness Allowances which has been enhanced from time to time i.e. 125% w.e.f.01/01/2016, 132% w.e.f.01/07/2016, 136% w.e.f.01/01/2017, 139% w.e.f.01/07/2017, 142% w.ef.01/01/2018 and 148% w.ef.01/07/2018, the instalment of 6% of Dearness Relief raising it to 148% with effect from 01/07/2018 or date of commencement of pension whichever is later. Further, the said Office Memorandum No. 12/1/2019-Fin(R&C) dated 11/02/2019 is also applicable to the following pensioners and should be paid relief accordingly.
- 3. In case of Goa State Government Pensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
- 4. This relief is not applicable to the following class of pensioners
 - a. Pensioners drawing pension, which is granted after Independence for Political consideration(Ex-Rulers).
 - b. Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
 - c. Pensioners of other states (PAO) Suspense) for whom separate orders are applicable.

- Instructions issued from time to time by this office as regards to payment of relief should be observed.
- Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.
- 7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2018 and have subsequently opted for payment of their pension through Bank may also be paid arrears from the date of their retirement or from 01/07/2018 whichever is earlier without waiting for any individual orders from this office.
