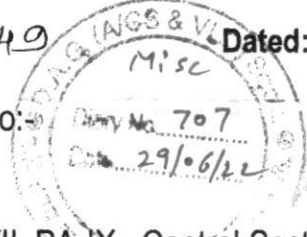



Since the order on relief contained in the above Government of Goa's Letter are applicable to Goa Government Freedom Fighters and Goa Freedom Fighter Family Pensioners under Freedom Fighter Welfare Rules, 2013, I am to authorize you to pay to the Goa Government Freedom Fighters Pensioners/Family Pensioners the installment of 7% of Dearness Relief raising it from **189% to 196% with effect from 01/07/2021.**

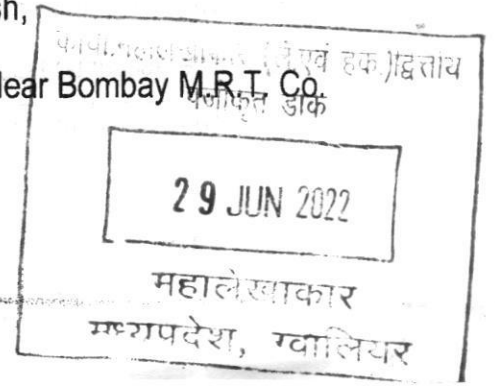
