# ORDER:-

A<sup>T</sup> In the G.O. 1<sup>st</sup> read above, orders were issued for sanctioning of consolidated pension to the University/ Government Degree Colleges and Aided teaching staff working in Private Aided Degree Colleges teachers who drew UGC Scales of Pay and retired from service prior to 01.01.2016. In para 16 of the said G.O., it was mentioned that "the orders on the arrears consequent on consolidation of the pension w.e.f. 01.01.2016 to 31.03.2019 will be issued separately.

2. In the reference 2<sup>nd</sup> read above, certain instructions have been issued extending the following benefits to the retired teachers those drawing UGC Scales, including payment of arrears:

- Addl Quantum of Pension (AQP) to the pensioners those drawing UGC Scale: Government has already issued necessary orders vide G.O.Ms.No. 34, Finance (HR.III-Pension, GPF) Department, dated:08.03.2022.
- b. Medical allowance, and other related benefits (other than AQP) shall be applicable as per G.O.Ms.No.02, Finance (HR.III-Pension, GPF) Department, dated:17.01.2022 & G.O.Ms.No.105, Finance (HR.III-Pension, GPF) Department dated:11.05.2022, and further orders if any and clarifications / instructions issued thereon.
- c. payment of arrears of UGC pensioners on consolidation of 2016 RPS (7<sup>th</sup> CPC), for the period from 01.01.2016 to 31.03.2019 and for the period from 01.04.2019 to till the date of revised pensions shall be paid, in four equal guarterly instalments as tabled hereunder.

The Associations have also requested to issue separate order as per para No.16 of the G.O.Ms.No.15, Higher Education (UE.II) Department dated:13.02.2019.

4. Government after careful examination of the matter, in continuation of the orders issued vide GO first read above, hereby order that the following benefits are extended to the retired teachers those drawing UGC Scales:

- a. Addl Quantum of Pension (AQP) to the pensioners those drawing UGC
  Scale: Government has already issued necessary orders vide G.O.Ms.No.
  34, Finance (HR.III-Pension, GPF) Department, dated: 08.03.2022.

Medical allowance, and other related benefits (other than AQP) shall be applicable as per G.O.Ms.No.02, Finance (HR.III-Pension, GPF) Dept., dated:17.01.2022 & G.O.Ms.No.105, Finance (HR.III-Pension, GPF) Dept., dated:11.05.2022, and further orders if any and clarifications / instructions issued thereon.
- c. Payment of arrears to UGC pensioners on consolidation of 2016 RPS (7<sup>th</sup> CPC) for the period from 01.01.2016 to 31.03.2019, and for the period from 01.04.2019 to till the date of revised pensions, shall be paid in four equal quarterly installments as tabled hereunder:

7. The Commissioner of Collegiate Education, A.P., Mangalagiri, Registrars of State Universities and all Treasury Officers/Pension Payment Officers shall take necessary action accordingly.
