ORDER

Subject:- Revision of rates of Dearness Allowance and Dearness Relief to the Haryana Government employees & pensioners/family pensioners, who are drawing their pay & pension/family pension as per 7th Pay/Pension Commission Structure, w.e.f. 1st January, 2026.

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) and Dearness Relief (DR) payable to Haryana Government employees & pensioners/family pensioners who are drawing their pay & pension/family pension as per 7th Pay/Pension Commission Structure from 58% to 60% of the basic pay & pension/family pension with effect from 1st January, 2026.

2. Enhanced DA & DR shall be paid with the pay & pension/family pension of May, 2026 and arrear for the months of January, 2026 to April, 2026 shall be paid in the month of June, 2026. The payment on account of DA & DR involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.

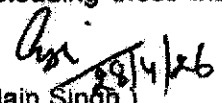

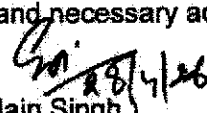
