Increase of Dearness Relief from 28% to 32% to the Mizoram Government Pensioners/ Family Pensioners with effect from

01.04.2023.

The undersigned is directed to convey sanction of the Governor of Mizoram for enhancing Dearness Relief @ 4% from the existing rate of 28% to 32% to the Pensioners and Family Pensioners under the Government of Mizoram with effect from 01.04.2023.

- 2. The Enhanced Dearness Relief @4% shall be paid in cash to all Pensioners/ Family Pensioners of Government of Mizoram who continue to draw Pension/ Family Pension.
- 3. Payment of Dearness Relief involving a fraction of rupees shall be rounded off to the next higher rupee.
- 4. Payment of enhanced Dearness Relief should be made in Indian Rupee (INR).
