Subject:- Clarification regarding Pension and other retirement benefits to employees who have retired on or after 01.01.2016.

Sir/Madam,

I have been directed to refer the letter No. 3/1/2021- 3 FPPC/281, dated 29.10.2021 on the subject cited above and to say that consequent upon the issuing of this letter, verbal queries are being received from some of the Administrative Departments. In view of the above, for Para 2.3 and para 10 of the said instructions, the following is further clarified:

- Pare 2.3 -According to rule 3.27 of Punjab CSR Vol-I Part-1, the superannuation age of disabled government employees (other than Group D employees) shall be sixty years.
- Para 10 For the payment of Ex-Gratia grant, the categories mentioned in para 10 of these instructions, shall be read as under:-

Regarding one time option to the Government pensioners who have retired between 1.1.2016 to 30.6.2021 to deposit the revised amount of commuted pension in the Government treasury.

Sir/ Madam,

I am directed to invite a reference on the subject cited above and to say that after careful consideration of the grievances of the government pensioners retired between 01.01.2016 to 30.6..2021, the Government has taken a conscious decision for the welfare of the Punjab government pensioners. The decision is as under:-

The one time option is granted to the government pensioners who have retired between 1.1.2016 to 30.6.2021 to deposit the amount received on account of revised commuted value of pension in the Government treasury. This will be subject to the following conditions:-

- a) The concerned pensioner will provide all the relevant documents and information in the prescribed performa (Annexure A) to the Pension Sanctioning Authority (PSA). The amount to be deposited shall be verified by the PSA. Thereafter, the pensioner shall deposit this amount (in lump sum) in the Government Treasury through challan by
- b) The Pension Sanctioning Authority (PSA) will send the pension case to the Accountant General (A&E) within two weeks to issue the revised
- c) Neither Government will charge any interest which would have accrued to the pensioner nor will pay any interest to the pensioner in this regard.
- d) A formal communication is being sent to the Principal Accountant General (A&E) Punjab for necessary instructions to their Officers/Officials to expeditiously dispose of the reference being made
- e) Those pensioners whose pension cases (for revised commuted value of pension) are pending in the Accountant General's office, can also opt for this option.
- f) The one time option is available only till 31.7.2023.

- 2. I am directed to invite a reference on the subject cited above and to say that the Government had taken a conscious decision to grant one time option to the Punjab government pensioners, who have retired between 01.01.2016 to 30.06.2021, to deposit the revised commuted value of pension in the Government treasury vide letter mentioned above. This option was available till 31.7.2023.
- 2. Now, after considering the grievances of the pensioners, the government has decided to extend the date of one time option to 31.03.2024 for depositing the revised commuted value of pension in the Government treasury for the government pensioners who have retired between 1.1.2016 to 30.6.2021.
- 3. This option can also be exercised by those pensioners, who have retired between 1.1.2016 to 30.6.2021 and whose pension is revised by the Accountant General, Punjab after the issuance of above cited instructions dated 05.06.2023.

Conditions prescribed in the instructions No. 3/4/2023-3FPPC/151 dated 05.06.2023 shall remain applicable.
