Subject : Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/07/2023

The Government of West Bengal, Judicial Department under their letter No. I/452744/2023-JJD/V/2A-14/17 dated 08/11/2023 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 42% to 46% with effect from 01/07/2023.**

Accordingly, in continuation to para 4 of this office circular No. Pen. Co-ordn./65 Vol.V/94 dated 27/09/2023, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 46% to the above category of pensioners / family pensioners with effect from **01/07/2023** where pension/family pension has been revised as per instruction of this office circular dated 27/09/2023, after proper adjustments of payment already made.


Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

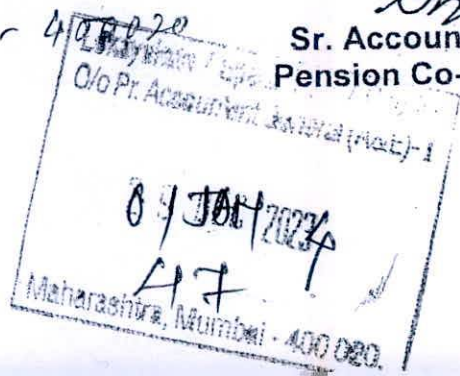
