The Director of Public Instruction, West Bengal under his letter No.253-C/Pen Dt.13.06.2025 has intimated that after retirement all Teaching Staff including Librarians and Graduate Laboratory Instructors of Government Aided Colleges are not entitled to get benefits of the West Bengal Health Scheme, allowed in terms of the G.O. No.1020-Edn(CS) dated 29/08/2018.

Accordingly all concerned Pension Disbursing Authority are requested to allow Medical Relief @ Rs.500/-(Rupees Five Hundred) per month w.e.f. 01.01.2020 as circulated under this office Circular No. *Pen.
