### GOVERNMENT ORDER NO. FD 16 SRP 2017, BANGALORE, DATED 30<sup>TH</sup> March 2017

Government are pleased to sanction increase in the rates of Dearness Allowance payable to the State Government Employees in the Revised Pay Scales 2012 from the existing 40.25% to 43.25% of Basic Pay with effect from 1st January 2017.

- These orders will apply to the full time Government Employees, Employees of Zilla Panchayats, Work Charged Employees on regular time scales of pay, full time Employees of Aided Educational Institutions and Universities who are on regular time scales of pay.
- For the purpose of grant of Dearness Allowance, the term 'Basic Pay' means, pay drawn by a Government Employee in the scale of pay applicable to the post held by him and includes:
  - a. Stagnation increment, if any, granted to him above the maximum of the scale of pay.
  - b. Personal Pay, if any, granted to him under sub-rule (3) of Rule 7 of the Karnataka Civil Services (Revised Pay) Rules, 2012.
  - c. Additional increment, if any, granted to him above the maximum of the scale of pay.
- Basic Pay shall not include any emoluments other than those specified above. 4.
- Government are also pleased to sanction increase in the rates of Dearness Allowance from the existing 40.25% to 43.25% of the Basic Pension/Family Pension with effect from January 2017 to the State Government Pensioners/Family Pensioners and Pensioners/Family Pensioners of the Aided Educational Institutions whose Pension/Family Pension is paid out of the Consolidated Fund of the State.
