Subject - Payment of Dearness Relief at the enhanced rate w.e.f. 01-01-2014 to the retired Judicial Officers of the State of West Bengal whose pension has been revised as per recommendation of Padmanabhan Committee.

In continuation to this office circular No Pen.Co-ordn./65 Vol.IV/149 dated 29/11/2013, it is stated that the Government of West Bengal, Judicial Department in their letter No 1631-J dated 11/04/2014 has sanctioned enhancement of the rates of dearness relief from 90% to 100% with effect from 01/01/2014 for their retired Judicial Officers/family pensioners (whose pension/family pension has been revised in terms of G.O. No 7014 - J and G.O No 7012 - J both dated 25/10/2010).

Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

All Pension Disbursing Authorities including Public Sector Banks are requested to make necessary arrangements for payment of dearness relief at the revised rate i.e. @ 100% with effect from 01/01/2014 to the above mentioned categories of pensioners/family pensioners after making proper adjustment of payment already made.
