I am directed to refer to this Department's letter of even number dated 28th April, 2014 on the above subject and to say that consequent upon grant of further Dearness Relief (DR) on pension/family pension to the retired members of All India Service <u>vide</u> Department of Pension & Pensioners Welfare's O.M. No.42/10/2014-P&PW(G) dated the 29th September, 2014 (copy enclosed), it has been decided that retired judges of Supreme Court/High Courts and family pensioners of such Judges would be entitled to Dearness Relief on pension /family pension at the rate of 107 % with effect from 1st July, 2014.

- 2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 3. The provision governing grant of Dearness Relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- 4. Other provisions contained in this Department's letter No.L-19016/3/97-Jus. dated 13th January, 1999 will remain unchanged.

Subject Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 1.7.2014.

The undersigned is directed to refer to this Department's QM No. 42/10/2014-P8PW(G) dated 9th April, 2014 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief (DR) payable to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 100 % to 107% w.e.f. 1st July, 2014.

- 2. These orders apply to (i) All Civilian Central Government Pensioners/Family Pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners and (v) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government pensioners from Pakistan, who are Indian Nationals but receiving pension on behalf of Government of Pakistan and are in receipt of ad-hoc ex-gratia allowance of Rs. 3500/- p.m. In terms of this Department's OM No. 23/1/97-P&PW(B) dated 23.2,1998 read with this Department's OM No. 23/3/2008-P&PW(B) dated 15.9.2008.
- 3: Central Government Employees who had drawn lump sum amount on absorption in a PSU/Autonomous body and have become eligible to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount in terms of this Department's OM No. 4/59/97-P&PW (D) dated 14:07:1998 will also be entitled to the payment of DR @ 107% w.e.f. 1:7.2014 on full pension i.e. the revised pension which the absorbed employee would have received on the date of restoration had he not drawn lump sum payment on absorption and Dearness Pension subject to fulfillment of the conditions laid down in para 5 of the O.M. dated 14.07.98. In this connection, instructions contained in this Department's OM No.4/29/99-P&PW (D) dated, 12:7:2000 refer.
- 4. Payment of DR involving a fraction of a rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended vide this Department's OM No. F. No. 38/88/2008-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension, will remain unchanged.


