Subject: Payment of Dearness Relief at the enhanced rate w.e.f. 01/07/2014 and onwards to the retired Judicial Officers of the State of West Bengal whose pension has been revised as per recommendation of Padmanabhan Committee.

In continuation to this office circular No Pen.Co-ordn./65 Vol.IV/46 dated 10/06/2014, it is informed that the Government of West Bengal, Judicial Department in their authority letter No 09–J dated 02/01/2015 has decided to allow their retired Judicial Officers including Higher Judicial officers in the rank of District Judges and family pensioners of the category to draw the dearness relief at the rate as admissible to the pensioners and family pensioners of the Central Government from time to time.

All Pension Disbursing Authorities including Public Sector Banks are, therefore, requested to make necessary arrangements for payment of dearness relief at the revised rate i.e. (a) 107% with effect from 01/07/2014 to the above category of pensioners/family pensioners whose pension / family pension has been regulated / revised in terms of the Judicial Department Memo No 7012 – J / 7014 – J dated 25/10/2010 after making proper adjustment of payment already made.

Besides, it is requested to allow dearness relief to such categories of pensioners/family pensioners in future at the rate sanctioned from time to time by the Government of India for their pensioners/family pensioners without further authorization from this office, till further instructions in this regard.
