2. GO(Ms) 55/2011/Home dated 24.2.2011

As per OM cited 1st, the Dearness Relief payable to Central Government pensioners/family pensioners has been enhanced from the existing rate of 113% to 119% with effect from 1.7.2015.

Government of Kerala as per orders cited 2nd have extended the benefit of increase in Dearness Relief sanctioned to Central Government pensioners/family pensioners to the retired State Judicial Officers/nominees without waiting for further orders from the State Government.

Hence, you are requested to honour the claim for enhanced Dearness Relief at the rate of 119% with effect from 1.7.2015, preferred by pensioners/family pensioners coming under the category of State Judicial Officers in respect of whom pension/family pension has been revised based on replacement scale came into force with effect from 1.1.2006.
