Sub: Grant of Dearness relief with effect from 01-01-2016 to the State Govt. pensioners/family pensioners drawing un-revised pension/family pension.

In continuation to this office circular No. Pen.Co-ordn/93/Vol-VI/236 dated 12/2/2015 it is stated that Govt. of W.B., in their Finance Department Memo No. 701 –F (Pen), dated 16/12/2015 (copy enclosed) have sanctioned revised rates of dearness relief @ 156% w.e.f. 01/01/2016 payable on the basic pension and dearness pension (introduced in terms of Memo No. 2415-F, dt. 27/03/2007) taken together of the State Government pensioners / family pensioners whose pensions/family pensions have not been revised in terms of Memo. No. 200-F(Pen), and 201-F(Pen) both dated 25/02/2009.

Payment of dearness relief on pension/family pension involving a fraction of a rupee shall be rounded off to the next higher Rupee.

All Pension Disbursing Officers are, therefore, requested to calculate the quantum of dearness relief on pension/family pension payable in each individual case and make necessary arrangements for its payment at revised rate as contained in the enclosed memo dated 16/12/2015 to the above category of W.B. Govt. pensioner/family pensioner after proper adjustments of payment, already made in this regard.

In this context, it is reiterated that the benefit of the above Memo is not admissible to the teaching and Non-teaching pensioner/family pensioners of Non-Govt. Educational Institution and Non Govt. Colleges. In their cases separate circular will be issued on receipt of specific Govt. orders in this regard from the respective Administrative Departments.

All Accountants General of other States are requested to arrange extra copies at their end, if necessary, for circulation within their State.

MEMORANDUM

Sub: Grant of Dearness Relief to State Government Pensioners/Family Pensioners whose pension/family pension has not been revised in terms of F.D. Memo No. 200-F(Pen) and No. 201-F(Pen) both dated 25.02.2009 @ 156% with effect from 01.01.2016.

In continuation of this Department Memo No. 35-F(Pen) dated 21.01.2015 sanctioning installment of relief with effect from 01.01.2015 to the State Government Pensioners/Family Pensioners whose pension/family pension has not been revised in terms of F.D. Memo No. 200-F(Pen) and No. 201-F(Pen) both dated 25.02.2009, the undersigned is directed to state that the Governor is pleased to decide that such State Government Pensioners/Family Pensioners shall draw Dearness Relief @ 156% of basic pension and dearness pension taken together with effect from January 01,2016 onwards in supersession of the rate mentioned in the Order dated 21.01.2015 as mentioned above.

- 2. The calculation of Dearness Relief shall be made taking into account the Basic Pension and Dearness Pension as introduced in this Department Memo No. 2415-F dated 27.3.2007.
- 3. Payment of relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.
- 4. It will now be the responsibility of the Pension Disbursing Authority to calculate the quantum of relief on Pension/Family Pension payable to each individual case and to make necessary adjustment for overpayment/underpayment, if any.
- 5. For the purpose of payment of relief sanctioned herein, the Principal Accountant General (A&E). West Bengal, will issue authority to the Public Sector Banks in Kolkata and the Accountant General of other States.
- 6. The Treasury/Sub-Treasury Officers in this State will give effect to this order without the authority of the Accountant General (A&E), West Bengal.
