
Subject:- Grant of Dearness Allowance on the Pension to Ex-Legislators of Haryana Legislative Assembly.

I am directed to invite a reference to sub-section 1AA of section 7A of the Haryana Legislative Assembly (Allowances and Pension of Members) Act, 1975 and to say that the Governor of Haryana is pleased to order that the Dearness Relief payable to the Pensioner/family pensioners of ex-Legislators of Haryana Legislative Assembly shall be enhanced from the existing rate of 200% to 212% of the basic Pension/ Family Pension and Dearness Pension/Dearness Family Pension of Ex-Legislators of Haryana Legislative Assembly w.e.f. 1st July, 2014 as conveyed by the Finance Department vide their letter No. 4/7/2009-2FR/26524, dated 12th December, 2014.

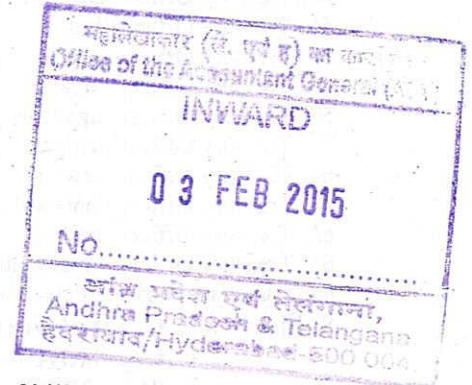
