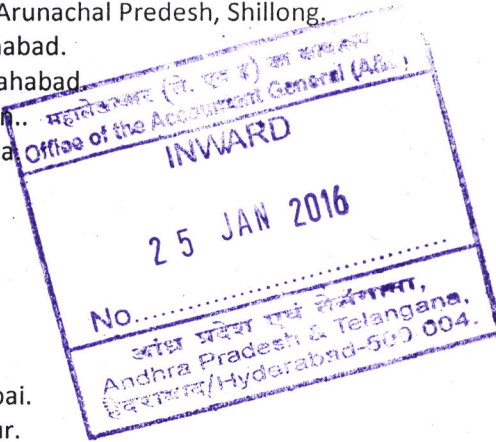


Subject:- Grant of Dearness Allowance on the Pension to Ex-Legislators of Haryana Legislative Assembly.


