SUB:-Grant of revised rates dearness relief applicable for the pensioners/family pensioners of Ex-Management Staff of North Bengal Medical College& Burdwan Medical College

In continuation to this office circular no Pen.Co-ordn/258/Vol-II/56 dated 30/5/2012, and circular No. Pen.Co-ordn/217/Vol-II/220 dated 21/12/2012 it is stated that Govt. of West Bengal Higher Education Department, University Branch in their Memo no.74 -Edn(U) dated 16/1/2013 and Memo No. 103-Edn(U) dated 27/1/2014 have sanctioned revised rates of dearness relief @52% with effect from 1/1/2013 and @58% with effect from 1/1/2014 respectively to the pensioners of State Aided Universities.

The aforesaid benefit will also be admissible to the pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical College and whose pension/family pension has been regulated under University Pension Rules as per Govt. of West Bengal, Health & Family Welfare Department, TOI Branch letter no. HF/O/TOI/114/2T-03/2010 dated 13/1/2012 and Memo No.31/HF/O/TOI/3P-28/2008(PT) dated 19/11/2012 respectively.

Accordingly, all Pension Disbursing Officers are requested to make necessary arrangements for payment of dearness relief @52% with effect from 1/1/2013 to 31/12/2013 and @58% with effect from 1/1/2014 onwards to all pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical Collegeand whose pension/family pension has been regulated under University Pension Rules after proper adjustment.
