Subject: Grant of Dearness Relief to West Bengal Govt. pensioners/family pensioners w.e.f. 01-01-2015.

In continuation to this office circular No. Pen. Co-ordn./93/Vol-V/174 dated 31/12/2013 it is stated that Govt. of W.B., Finance Department, Pension Branch in their Memo no. 12-F (Pen) dated 9/1/2015 (copy enclosed) have sanctioned revised rates of dearness relief @ 65% with effect from 01/01/2015 payable to their pensioners/family pensioners on basic pension/basic family pension, regulated in terms of Memo. No. 200-F (Pen) or 201-F (Pen) both dated 25-2-2009, in supersession of the rates mentioned in the above circular dated 31/12/2013.

Payment of relief on pension/family pension involving a fraction of a rupee shall be rounded off to the next higher Rupee.

You are, therefore, requested to make necessary arrangements for payment of dearness relief at the rate as contained in the enclosed memo dated 9/1/2015 to all eligible West Bengal Govt. pensioners/family pensioners after proper adjustment.

In this context, it is reiterated that separate circulars will be issued with regard to grant of dearness relief on pension/family pension to the teaching and non-teaching pensioner/family pensioners of Non-Govt. Educational Institution and Non Govt. Colleges on receipt of specific orders from the respective Administrative Departments.

Accountants General of other States are requested to arrange extra copies of the said Govt. order at their end, if necessary, for circulation within their State.

MEMORANDUM

Sub: Grant of Dearness Relief to State Government Pensioners /Family Pensioners with effect from 1st January, 2015.

In continuation of this Department Memo No.552-F (Pen) dated 24.12.2013 sanctioning instalment of relief to the State Government Pensioners/Family Pensioners with effect from 01.01.2014 onwards, the undersigned is directed to state that the Governor is pleased to decide that the State Government Pensioners/Family Pensioners shall draw Dearness Relief @ 65% of basic pension/basic family pension with effect from 1st January, 2015 onwards in supersession of the rates mentioned in the Order dated 24.12.2013 as mentioned above.

- 2. Payment of relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.
- 3. It will now be the responsibility of the Pension Disbursing Authority to calculate the quantum of relief on Pension/Family Pension payable to each individual case.
- 4. For the purpose of payment of relief sanctioned herein, the Principal Accountant General (A&E), West Bengal will issue authority to the Public Sector Banks in Kolkata and the Accountant General of other States.
- 5. The Treasury/Sub-Treasury Officers in this State will give effect to this order without the authority of the Accountant General (A&E), West Bengal.
- 6. This benefit of Dearness Relief as has been sanctioned in the aforesaid Memorandum for the State Government Pensioners/Family Pensioners will also be allowed to the teaching and Nonteaching pensioners of State aided Non-Government Educational Institutions and Pensioners of Statutory Bodies/Government Undertakings/Panchayats including Panchayat Karmee and Municipal Corporations/Municipalities/Local Bodies etc. who are in receipt of Dearness Relief @ 58% of basic pension with effect from 1st, January 2014. In such cases the respective Administrative Department may sanction the benefit of Dearness Relief @ 65% with effect from 1st January, 2015 to the pensioners concerned under their control without making any further reference to Pension Branch of this Department.
- 7. It has also been decided that in the case of Public Undertakings/Statutory Bodies the additional expenditure should be borne by such Undertakings/Bodies themselves out of their own resources or out of financial assistance provided for them in the budget and that no additional financial assistance will be given to them on account of sanction of this instalment of Dearness Relief.
