**Subject: Grant of Dearness Relief on pension to the Pensioners/Family Pensioners of the Teaching & Non-Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West Bengal with effect from 1-1-2015**


In continuation to this Office Circular No. Pen. Co-ordn./111/Vol.VI/259/Vol-II/215 dated 10/3/2014 it is stated that Govt. of West Bengal, School Education Department, Planning & Budget Branch in their Memo No.43-SE (P&B)/5B-51/2004 dated 10/2/2015 have sanctioned Dearness Relief @ 65% of basic pension/family pension with effect from 1/1/2015 for the Pensioners/Family Pensioners of the teaching and non-teaching employees of Non-Govt. Aided/Sponsored Educational Institutions etc.

The benefit is applicable to the pensioners/family pensioners who are drawing pension/family pension under the scheme D.C.R.B.,1981 of West Bengal Non-Govt. Sponsored/Aided Educational Institutions (Primary & Secondary), as well as the pensioners/ family pensioners who retired/died in harness prior to 01-04-1981 and are governed under GO No. 163-Edn (B) dated 15-06-1990 or GO No. 341-Edn(B) dated 26-11-1993 and whose pension/family pension have been revised/regulated under Memo. No 73-SE(B),dated 19.5.2009 or Memo. No 74-SE(B),dated 19.5.2009 **excluding** the pensioners of D.A. getting Institutions.

Payment of Dearness Relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of dearness relief to pensioners/family pensioners, such as, regulation of dearness relief on pension/family pension during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., as contained in Finance Department's Memo No. 7533-F dated 06-07-1988 will remain unchanged.

All Pension Disbursing Authorities are, therefore, requested to make necessary arrangements for payment of Dearness Relief @65% with effect from 1-1-2015 on revised basic pension Pension/Family Pension to the above categories of Pensioners/Family Pensioners whose pension/family pension has been revised as per recommendations of the 5<sup>th</sup> pay commission, subject to proper adjustment.

***SUB:- Grant of revised rates of dearness relief with effect from 1/1/2015 to the pensioners/family pensioners of Ex-Management Staff of North Bengal Medical College& Burdwan Medical College***

In continuation to this office circular no Pen.Co-ordn/258/Vol-II/217/Vol-II/8 dated 7/4/2014, it is stated that the Govt. of West Bengal, Higher Education Department, University Branch in their Memo no.40-Edn(U)/N/1U-01/14 dated 19/1/2015 have sanctioned revised rates of dearness relief **@65% with effect from 1/1/2015** to the pensioners of State Aided Universities.

The aforesaid benefit will also be admissible to the pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical College and whose pension/family pension has been regulated under University Pension Rules as per Govt. of West Bengal, Health & Family Welfare Department, TOI Branch letter no. HF/O/TOI/114/2T-03/2010 dated 13/1/2012 and Memo No.31/HF/O/TOI/3P-28/2008(PT) dated 19/11/2012 respectively.

Accordingly, all Pension Disbursing Officers are requested to make necessary arrangements for payment of dearness relief **@65% with effect from 1/1/2015** to all pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College as well as Burdwan Medical College and whose pension/family pension has been regulated under University Pension Rules after proper adjustment.
