Subject :- Grant of dearness relief on pension/family pension to the pensioners/family pensioners of Non Govt. Colleges w.e.f. 1.1.2016


In continuation to this office. Circular No. Pen.Co-ordn./51/Vol-VI/204/Vol-II/240 dated 18/2/2015 it is stated that Govt. of West Bengal in their Higher Education Department Memo no. 82-Edn(CS)/1P-1/2013, dated 20/01/2016 have sanctioned dearness relief to the pensioners/family pensioners of the **teaching and non-teaching staff** of the State-Aided **Non-Government. Colleges** in this State @ **75% with effect from 1/1/2016.**

All concerned Pension Disbursing Officers are, therefore, requested to allow to the above categories of pensioners/family pensioners dearness relief @ **75% with effect from 1/1/2016** subject to proper adjustment of dearness relief already paid.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than in pension is drawn etc., will remain unchanged.
