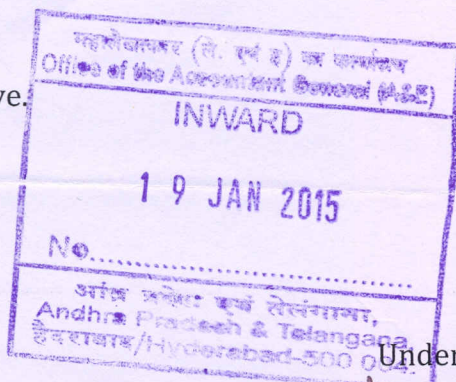

2. The enhanced Dearness Relief @10% shall be paid in cash to all Pensioners/Family Pensioners of Government of Mizoram who continue to draw Pension/Family Pension.

3. Payment of Dearness Relief involving a fraction of rupees shall be rounded off to the next higher rupee.

4. Payment of enhanced Dearness Relief should be made in Indian rupee(INR).

Sub: Non receipt of Government Of Mizoram GOs raising Dearness Relief by AG Andhra Pradesh.

I have joined Mizoram Health services in December 1973 and taken voluntary retirement in the year 1998 as senior Specialist. After retirement I have been drawing pension from sub treasury at Visakhapatnam city in the state of Andhra Pradesh.

Since December 2013 Government of Mizoram has issued notifications enhancing Dearness relief to Mizoram Government pensioners twice ie 80% to 90% and 90% to 100%. Since I am not receiving the enhanced DR I sent an email to PAG Andhra Pradesh at Hyderabad to do the needful. I was informed by AG Andhra Pradesh that they have not received any GOs raising DR from AG Mizoram under special seal for the last one and half years and hence cannot authorize payment. A Copy of the same is enclosed as Annexure-1 for ready reference.

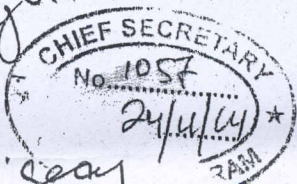
I represented the matter to Secretary to GOM, Finance Dept and Principal Accountant General Mizoram on 21st July 2014. Responding to my letter Pu Rosiamliana, Under Secretary to the GOM Finance Department sent a letter on 10th September 2014 to the Chief Controller of Accounts & Treasuries Mizoram requesting him to send the enhanced DR notifications to PAG Mizoram after embossing Special seal Authority. Copy of the letter is enclosed as annexure-2 for ready reference.

In all the GOs issued by Finance Department of Mizoram a copy is marked to Principal Accountant General Mizoram Aizawl with a request to circulate the same to AGs of all States/UTs after embossing Special Seal Authority. A copy is also marked to the Chief Controller of Accounts, Accounts and Treasuries Mizoram. I do not know for what reason these GOs were not sent to AGs of other States for the last one year.

I spent prime part of my life serving the Government of Mizoram. Due to non receipt of the notifications by AG Andhra Pradesh I am not receiving the enhanced Dearness relief benefit during last one year.




