Subject Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/07/2019.

Sir,

The Government of West Bengal, Judicial Department under their letter No. 4353-J/JD/V/2A-14/17 dated 31/10/2019, has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been enhanced from 154% to 164% with effect from 01/07/2019.

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.IV/03 dated 01/04/2019, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 164% to the above category of pensioners / family pensioners with effect from 01/07/2019 after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 -- Pension and other Retirement Benefits -- 01 -- Civil -- 101 Superannuation and Retirement allowances etc.
