Subject:- Grant of dearness relief on pension/family pension to the pensioners/ family pensioners(teaching & non-teaching) of State Aided Non Govt. Colleges w.e.f. 1/05/2024.

In continuation to this office circular No.s Pen.Co-ordn./51/Vol-VIII/204/Vol-II/8 dated 10/04/2024, it is stated that the Govt. of West Bengal, Higher Education Department, in their order no. 235(31)-Edn(U)/HED-12012(21)/2024-UNV SEC-Deptt.v of HE dated 06/3/2024 have sanctioned dearness relief @ 14% with effect from 01/05/2024 on the basic pension/family pension so revised as per Memo No. 210-Edn (CS) dated 14/02/2020 or Memo No. 214-Edn (CS) dated 14/02/2020, circulated under this office circular No. Pen. Co-ordn./204/Vol-II/198 dated 17/03/2020 and Pen. Co-ordn./204/Vol-II/197 dated 17/03/2020 respectively to the pensioners/family pensioners of the teaching and non-teaching staff of the State-Aided Non-Government Colleges in this State.

Besides, the pensioners/family pensioners arising out of teaching/nonteaching employees of State aided Non-Govt. Colleges, who are still drawing pre-revised pension/family pension as per ROPA2009, will get Dearness Relief @161% with effect from 01/05/2024 till their pension/family pension is revised.

All concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief on revised rates of pension/family pension @ 14% and on un-revised rates of pension/family pension @161% with effect from 01/05/2024 to the above categories of pensioners/family pensioners.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the nearest rupee in each case.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than one pension is drawn etc., will remain unchanged.

Accountants General of other States are requested to arrange additional copies of the said Govt. order at their end, if necessary, for circulation within their State.

Subject:- <u>Grant of Dearness Relief on pension to the Pensioners/Family Pensioners of the Teaching & Non-</u> Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West Bengal with effect from 1/3/2023, 1/1/2024 and 1/5/2024.

In continuation to this office earlier circular No./111/Vol.VII/259/Vol-II/148 dated 12/03/2021, it is stated that Govt. of West Bengal, School Education Department, Planning & Budget Branch in their Memo. Nos. 60-SED-18099/40/2020-PB SEC-Dept. of SE dated 1/3/2023, 10(13)-SED-18099/40/2020-PB SEC-Dept.of SE dated 6/1/2024 and 166- SED-18099/40/2020-PB SEC-Dept. of SE dated 11/3/2024 have forwarded the Govt. of West Bengal, Finance (Audit) Department Memo No.850-F(P2) dated 24/2/2023, 56-F(P2) dated 3/1/2024 and 1090-F(P2) dated 1/3/2024 for sanctioning dearness relief @ 6% w.e.f. 1/3/2023, @10% w.e.f 1/1/2024 and @14% w.e.f 1/5/2024 respectively for those pensioners/family pensioners of Govt. aided Educational Institutions who are drawing pension/family pension at revised rates on the basis of Memo. No. 52/ES/P/P&B/10M-99/2019 dated 14/02/2020 (circulated under this office circular No. Pen. Co-ordn./259 Vol. II/210 dated 27/4/2020).

The benefit is applicable to the pensioners/family pensioners who are drawing pension/family pension under the scheme D.C.R.B. 1981 of West Bengal Non-Govt. Sponsored/Aided Educational Institutions (Primary & Secondary) excluding the pensioners of D.A. getting School.

Payment of Dearness Relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the nearest rupee.

Other provisions governing grant of dearness relief to pensioners/family pensioners, such as, regulation of dearness relief on pension/family pension during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., as contained in Finance Department's Memo No. 7533-F dated 06-07-1988 will remain unchanged.

All Pension Disbursing Authorities are, therefore, requested to make necessary arrangements for payment of Dearness Relief @6% with effect from 1/3/2023, @10% with effect from 1/1/2024 and @14% with effect from 1/5/2024 on revised basic Pension/Family Pension admissible as per recommendations of the 6th pay commission, to the above categories of Pensioners/Family Pensioners after proper adjustment of amount already paid.
