

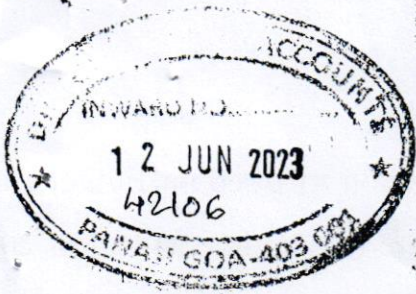

Sub: - Grant of Dearness Relief to Goa State Freedom Fighter Pensioners of Government of Goa-Revised rate effective from 01/01/2023 @ 42%,

1. The Government of Goa, Department of Home (General), Secretariat, Porvorim-Goa, vide letter No. 11/4/2012-HD(G)/1596 dated 08th June 2023 have conveyed the sanction for revision of Dearness Relief to Goa State Freedom Fighters. The copy of the said letter is enclosed for information and necessary action.
2. Since the order on relief contained in the above Government of Goa's Letter are applicable to Goa Government Freedom Fighters and Goa Freedom Fighter Family Pensioners under Freedom Fighter Welfare Rules, 2013, I am to authorize you to pay to the Goa Government Freedom Fighters Pensioners/Family Pensioners the installment of 4% of Dearness Relief raising it from **38% to 42% with effect from 01/01/2023.**
3. In case of Goa State Freedom Fighters/Family Pensioners drawing pension in other States, the instructions contained in above Letter may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
4. **This Dearness Relief is only applicable to the Goa State Freedom Fighter Pensioners/ Family Pensioners.**
5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
6. Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.
7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2016 and have subsequently opted for payment of their pension through Bank may also be paid arrears without waiting for any individual orders from this office.
8. The receipt of this letter may please be acknowledged.

Subject : Regarding Dearness Allowance to the Goa State
Freedom Fighter Pensioners

Sir,

I am directed to refer to the above subject and to state that the Government of Goa is paying monthly pension to freedom fighters registered with the State Home Department as a mark of respect for their selfless contribution to the freedom struggle of Goa. The said pension was being paid as a lump sum amount of Rs. 6000/- upto 31.03.2013. However w.e.f. 01/04/2013, the pension payment has been linked with dearness allowance as per the D.A. rates announced by Central Government and as adopted by Government of Goa vis-a-vis State Government employees.

In this regards, it is to inform you that, Government of Goa, under "The Goa Freedom Fighters Welfare (Amendment) Rules, 2022, as per Amendment to Rule 4- In Rule 4 of the Goa Freedom Fighters Welfare Rules, 2013, for the expression 'Rs. 3500/- plus applicable Dearness Allowances as per the rate announced by Central Government from time to time', the expression "Rs. 9000/- plus applicable Dearness Allowance as per the Order No. 8/1/2016-Fin(R&C)/(A) dated 30-11-2016 under 7th Pay Commission' shall be substituted. vide Notification No. 11/463/90-HD(G)/629 dated 23/02/2023, published in the Official Gazette No. Series I No. 48 dated 02/03/2023.


Now, the revised pattern of payment of pension to freedom fighters/family pensioners under the Goa Freedom Fighters Welfare (Amendment) Rules, 2022 is as under, the Government has approved for release of Dearness Relief to the Goa Freedom Fighters :

Sr. No.	Description	Amount	Dearness Allowance
1	Basic Monthly Pension	Rs. 9000/-	1) 38% to 42% (i.e. 4%) w.e.f. 01-01-2023.
2	Add Dearness Allowance	DA at the rate announced by Central Government and adopted by the State Government vis-à-vis Government employees.	
3	Add Fixed Medical Allowance	Rs. 3000 /-	

You are, therefore, requested to direct all Banks/Pension disbursing authorities for payment of freedom fighters pension under the Goa Freedom Fighters Welfare (Amendment) Rules, 2022. It is also requested that future pension payments may please be revised as and when the dearness relief rate is enhanced.
