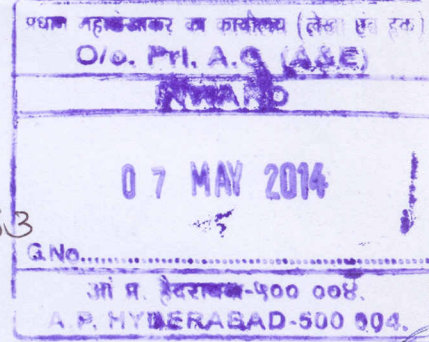

**GOVERNMENT ORDER NO. FD 7 SRP 2014,  
BANGALORE, DATED 11<sup>th</sup> April 2014**

Government are pleased to sanction increase in the rates of Dearness Allowance to Teaching Staff who are on UGC/AICTE/ICAR scales of pay and to Judicial Officers on NJPC pay scales from the existing **90% to 100%** of the basic pay with effect from **1<sup>st</sup> January 2014**.

2. For the purpose of this order, the term 'Basic Pay' means, the pay drawn by a Government employee in the UGC/AICTE/ICAR and NJPC scales of pay applicable to the post held by him.
3. Basic Pay shall not include any other emoluments.
4. Government are also pleased to sanction increase in the rates of Dearness Allowance to NJPC Pensioners/Family Pensioners from the existing **90% to 100%** of the basic pension/family pension with effect from **1<sup>st</sup> January 2014**.
5. The increase in Dearness Allowance admissible under this order is payable in cash until further orders.
6. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
