Sub: - Grant of Dearness Relief to State Government Pensioners/ Family Pensioners - Revised rate effective from 01/07/2019.

- 1. The Government of Goa, Finance (Rev. & Cont.) Department Secretariat, Porvoring, vide letter No. 12/3/82-Fin(R&C)Vol. I / 4191 dated 12th November 2019 has conveyed the sanction for revision of Dearness Relief to the Pensioners/Family Pensioners of Goa Government as contained in Office Memorandum No. 42/04/2019-P&PW(D) dated 21st October 2019 issued by Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension, & Pensioners Welfare, New Delhi. The copy of the said Office Memorandum is enclosed for information and necessary action.
- 2. Since the order on relief contained in the above Government of India's Office Memorandum are applicable to Goa Government Pensioners and Family Pensioners, I am to authorize you to pay to the Goa Government Pensioners/Family Pensioners the installment of 5% of Dearness Relief raising it to 17% with effect from 01/07/2019 or date of commencement of pension whichever is later. The Dearness Relief @17% to be paid to the pensioners with arrears effective from 01/07/2019 to 31/10/2019 alongwith pension for the month of November 2019. Further, the sanction conveyed vide letter No. 12/3/82-Fin(R&C) Vol.1/4191 dated 12th November 2019 is also applicable to the following pensioners and should be paid relief accordingly.
 - (a). Ex-gratia pensioners (Montepio pensioners, pensioners drawing pensions on account of service rendered to Portuguese colonies and institute Ultramarine Pensioners) drawing pensions under C/B/D and E series.
 - (b). Pensao de Sangue pensioners.
 - (c). Pensioners receiving pension under triple benefit scheme.
 - (d). Recipients of Ex-gratia i.e. Familles of deceases pensioners/employees who were governed under EFU.
 - (e). Pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under series.
- 3. In case of Goa State Government ensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.

- This Dearness relief is not applicable to the following class of pensioners.
 - Pensioners drawing pension, which is granted after Independence for Political consideration(Ex-Rulers).
 - b. Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
 - Pensioners of other states (PAO) Suspense for whom separate orders are applicable.
 - M.L.A. Pensioners.
 - Freedom Fighters of Govt. of Goa.
- 5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
- 6. Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.
- 7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2019 and have subsequently opted for payment of their pension through Bank may also be paid arrears from the date of their retirement or from 01/07/2019 whichever is earlier without waiting for any individual orders from this office.
