The Government of West Bengal, Judicial Department under their letter No. I/385767/2023-J/JD/V/2A-14/17 dated 13/04/2023 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been enhanced from 212% to 221% with effect from 01/01/2023.

Co-ordn./65 Vol.V/128 dated 31/10/2022, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 221% to the above category of pensioners / family pensioners with effect from 01/01/2023 after proper adjustments of payment already made.
